The single storey proposed 5 meter rear extension will be an improvement to the existing property. This will create more living habitable living space. The single storey 5 meter rear extension corresponds and is in line with Permitted development rights for householder, as shown in the diagram below. Reference to Class A. 1. The proposal is not in designated land 2. The proposed area is 30.78 m²; this does not exceed the 50% limit of land around the original house. This is well within 50% of the surrounding area of the original house. 3. The proposal does not sit in front of the original house and does not front a highway. 4. The proposed materials for the extension will match the materials of the existing house. 5. The proposal has the same width as the original house which is within permitted development. 6. The proposal height of the single storey rear extension is not more than 3m complying with the guidelines of Prior Approval: Larger Home Extensions. The maximum height is 4 m. 7. The proposal does not extend higher than original eaves level. 8. The enlarged part of the dwelling house would not extend beyond a wall which forms the principal elevation of the original dwelling house.
