The pre-application advice regarding the loft extension raised concerns regarding the enlarged and new dormers being proposed on the side slopes of the roof, and suggested that a Permitted Development may be more suitable route for that aspect of the design. The pre-application advice generally viewed the originally proposed rear extension favourably, therefore we have prepared the current application only covering the extensions to the roof, with reduced size of the proposed dormers to comply with the maximum allowed additional volume under Permitted Development Rights for Householder, while a separate Householder Planning Application is to cover the ground floor rear extension.
