Condition 3 states that

The development hereby permitted shall not be commenced until detailed design and method statements (in consultation with Transport for London), have been submitted to and approved in writing by the local planning authority which:-

Provide details as to how the mobile office can be lifted into position including the use of mobile crane, hiab and any other lifting machinery.-

Demonstrate that lighting to illuminate the car pound area should not impair the drivers on the operational railway and should be faced away from the railway elevation and neighbouring residential properties.

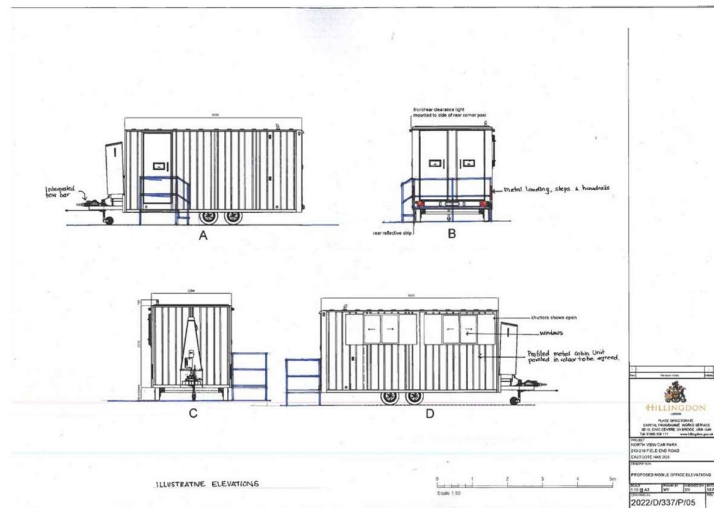

**We detail below how the mobile office is being towed onto site**

The Mobile office is a towable office as detail in Planning App Drawing 2022/D/337/05



This mobile office will be towed through the carpark with suitable sized vehicle ( van ) to the location as identified in the plan through the gates and unhitched and fixed into place at location 2022/D/337/P/03A (location marked in Red below )

There is no requirement to use mobile crane, hiab and any other lifting machinery. Towed into place (on wheels).

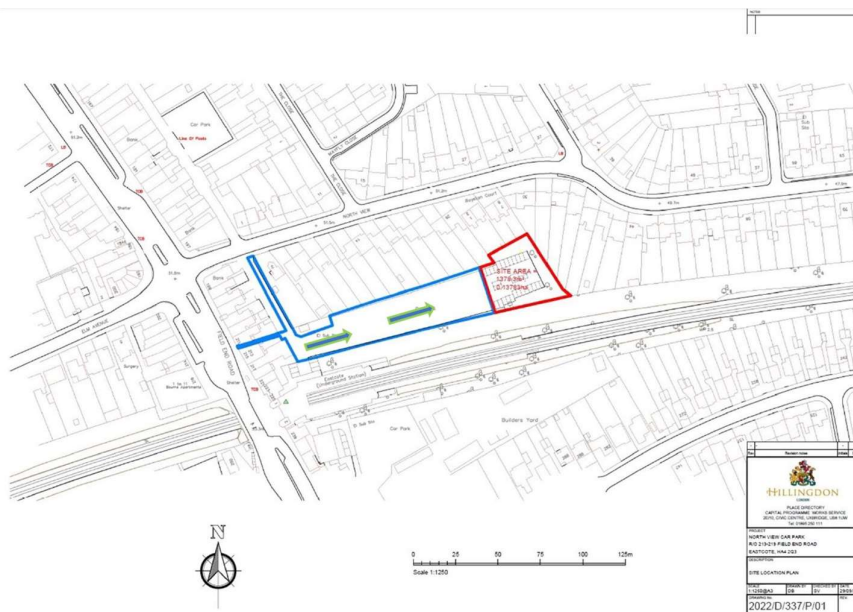
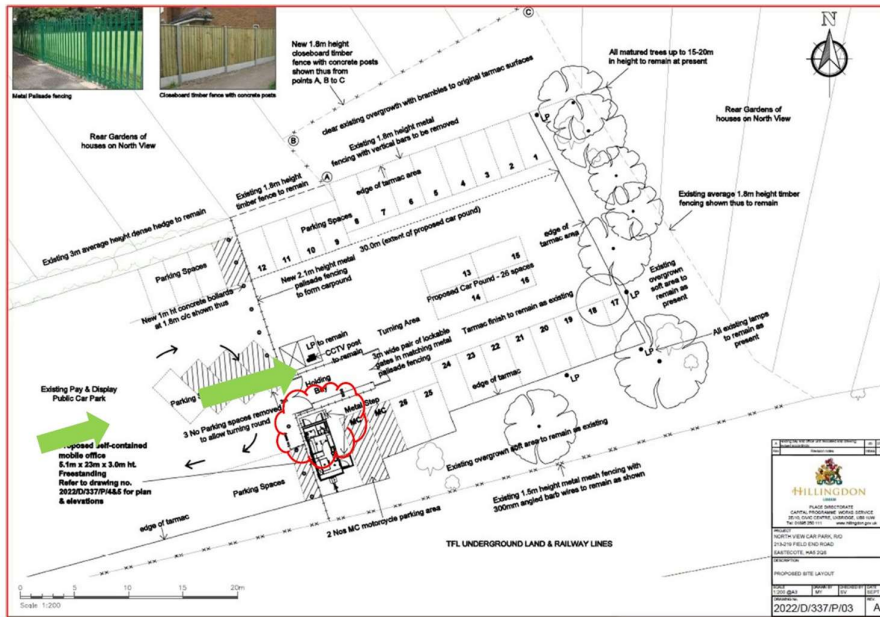
