All dwelling apartments are proposed as car free given the highly serviceable location in the center of Hayes.

As the proposed works concerns the conversion of an existing building, we will be commissioning a professional surveyor to undertake a refurbishment survey, thereby ensuring we are able to locate and identify asbestos-containing materials (ACMs) including those hidden within the building fabric, before any structural work begins in order to comply with the legal requirement for all ACMs to be removed, as far as reasonably practicable, before major refurbishment or demolition.

Whilst the existing internal ground floor level is located circa 70cm above external pavement level, the proposed 3 x stair core entrance doors will be provided with a level threshold and a polymer concrete drainage channel with 1m cast iron grate, to ensure rainwater that could otherwise enter the building is safely diverted away.

All dwelling apartments will be provided with compliant soundproofing within both party and partition walls in accordance with Building Regulations Part E. The L- shaped building is proposed to be severed where it turns to face onto Crown Close, whilst the Station Road half of the building is to remain unaltered (let to Poundland).
