Why do you consider that a Lawful Development Certificate should be granted for this proposal?

1. A volume allowance of less than 50 cubic metres additional roof space for semi detached house. Total Volume = 47.86m³ (Less than 50m³)
2. No part of the addition is to extend beyond the height of the ridge of the main roof of the house.
3. The front "Velux" style roof-light windows will not protrude more than 150mm above the plane of the roof slope
4. All materials are to match existing.
5. The new dormer is to be set back greater than 200mm from eaves of existing roof.
6. The property is not known to be in a "designated area" and the designer has not been made aware of any Pre-existing planning conditions/Article 4 Agreements limiting permitted development rights.
7. The property is not in a conservation Area
8. The flank first-floor bathroom window is to be fixed shut and fully obscure.

Therefore as far as can be reasonably determined works appear to be Permitted Development. For formal confirmation a certificate of lawful development should be applied for.
