Changes to fenestration of the rear extension element, reduction of roof form from pitched glass to flat roof with roof windows, and changes to internal layout.

Please state why you wish to make this amendment

1. Obscured glaze along number 13 Marsworth to be replaced with bricks to prevent overlooking, daylight will be restricted due to existing boundary fence.
2. Pitched glass roof to be replaced with flat roof to match proposed side extension roof form and neighbouring extension roof form at number 11 Marsworth.
3. Introduction of 4 roof domes instead of entire roof being from glass like a conservatory.
4. Introduction of rear extension masonry columns of both sides of the patio doors to allow structural engineer to design suitable lintel(s) to support the patio door opening and roof structure.
5. Move proposed bathroom into previously proposed utility room, to create a larger living space in the proposed extension.
