Details of the pre-application advice received

Enforcement notice received with some preliminary advice following investigation of works commencing.

Notably comments from the conservation officer stating that a new boundary should be reinstated for security reasons and preserving the setting of the listed building, suggesting the boundary should be 'of appropriate design for the listed build such as a simple timber post and rail fence, estate railing or low wall and hedging, metal railings all the way along not be appropriate as this is more typical of town housing. Reinstalling the existing gates would be acceptable but careful thought will be need to be given to the rest of the boundary treatment, a low wall with hedging might be most appropriate in this context'.
