The proposed loft conversion, rear dormer, front roof windows and additional windows should be considered permitted development because:

- The materials must be similar in appearance to the existing house.
- The volume of enlargement will not exceed the original roof space by more than 50 cubic metres.
- The proposals will not exceed the height of the existing roof.
- On the principal elevation of the house the proposals will not extend beyond the existing roof slope.
- The proposed side-facing window will be be obscure-glazed and non opening.
- The new dormer will be set back 20cm from the original eaves
- The roof enlargement does not overhang the outer face of the wall of the original house
- The proposed roof windows will be limited to 150mm beyond the plane of the slope of the original roof when measured from the perpendicular with the external surface of the original roof
