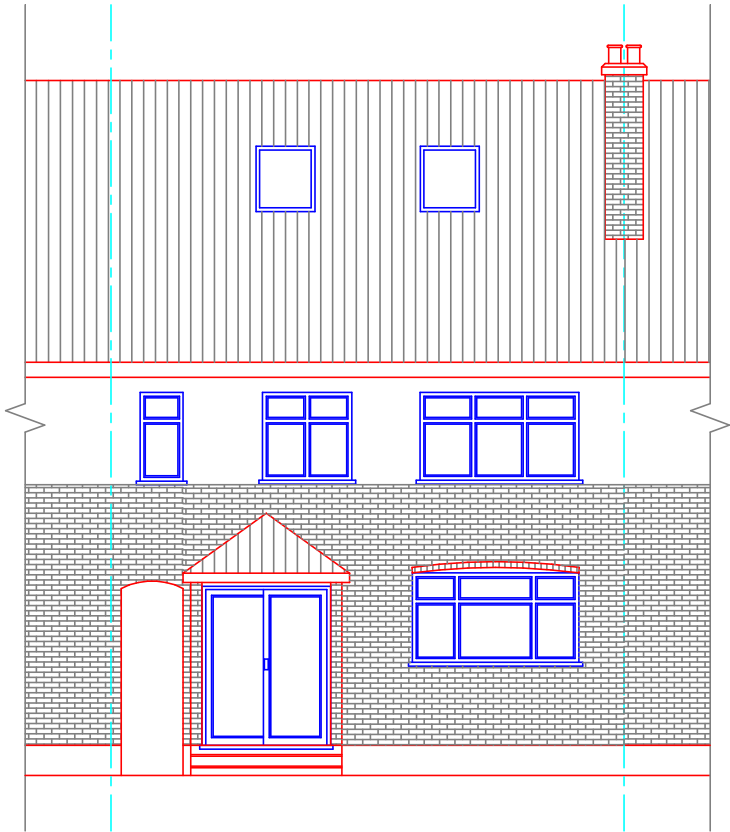
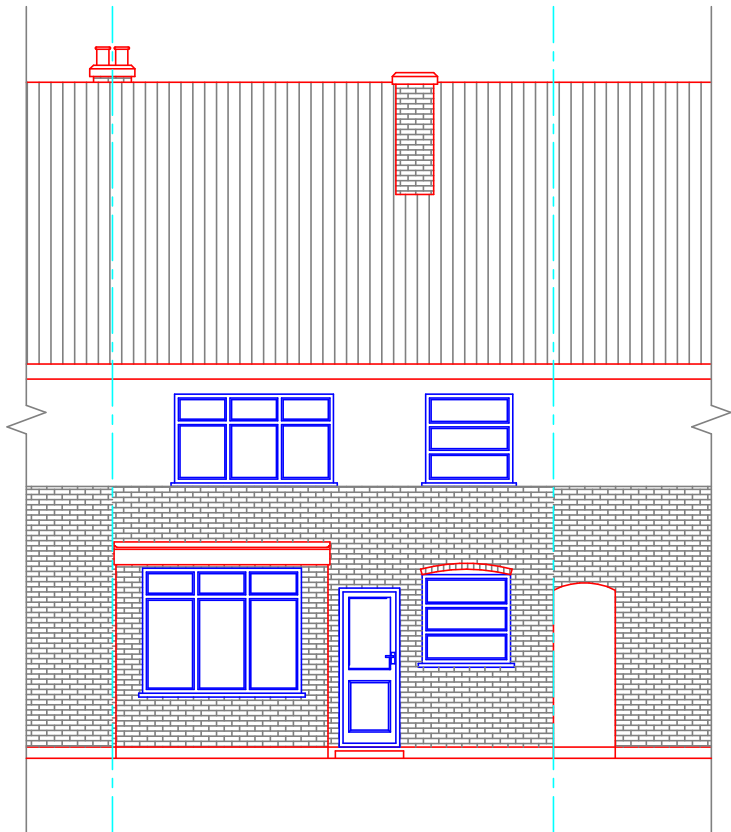


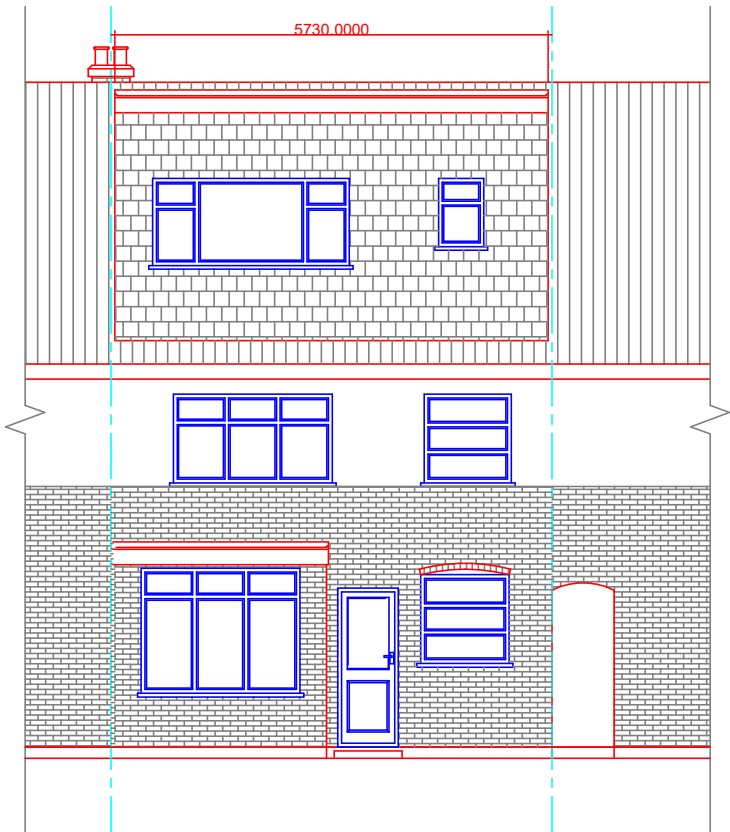
EXISTING FRONT ELEVATION



PROPOSED FRONT ELEVATION

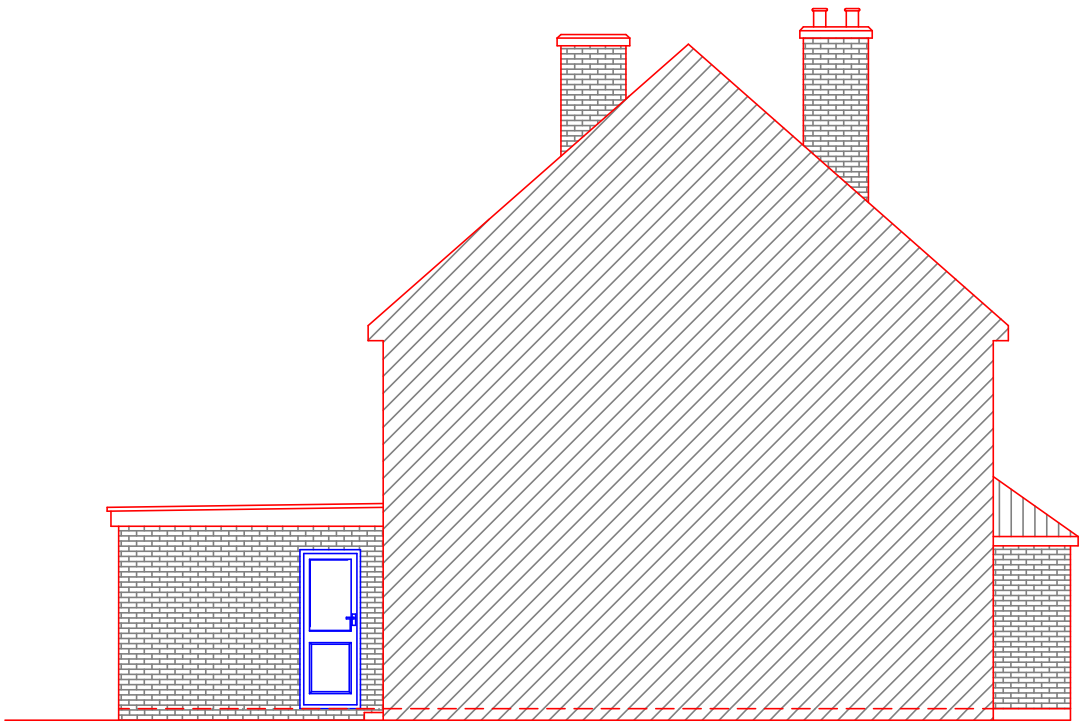


EXISTING REAR ELEVATION

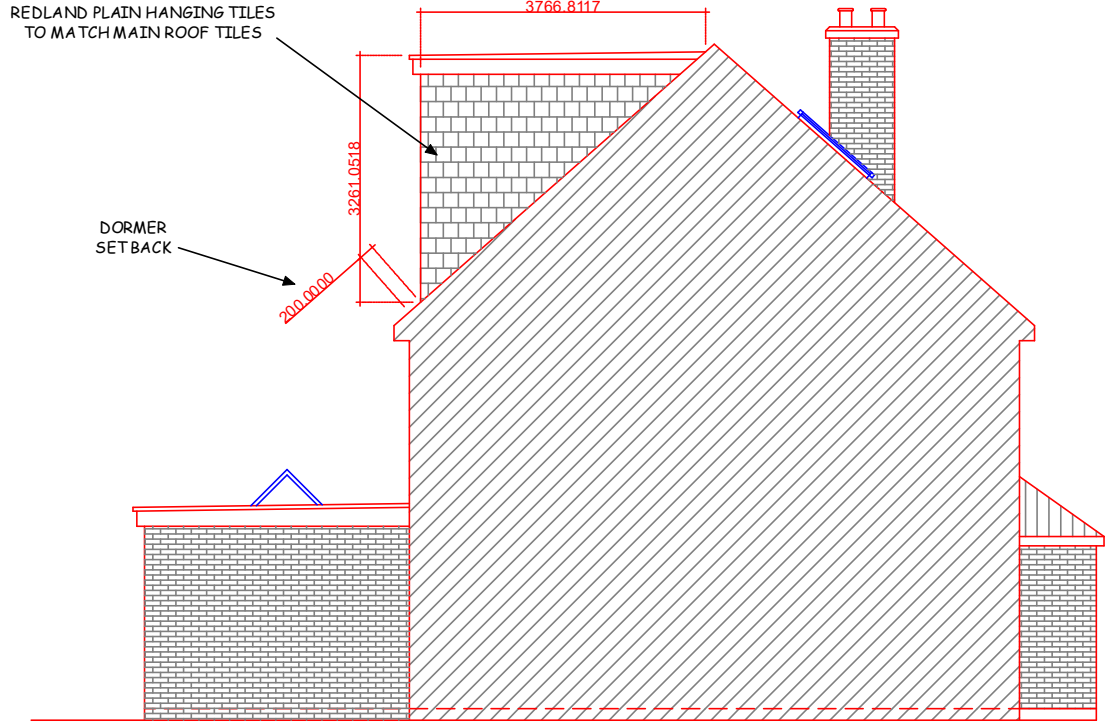


PROPOSED REAR ELEVATION

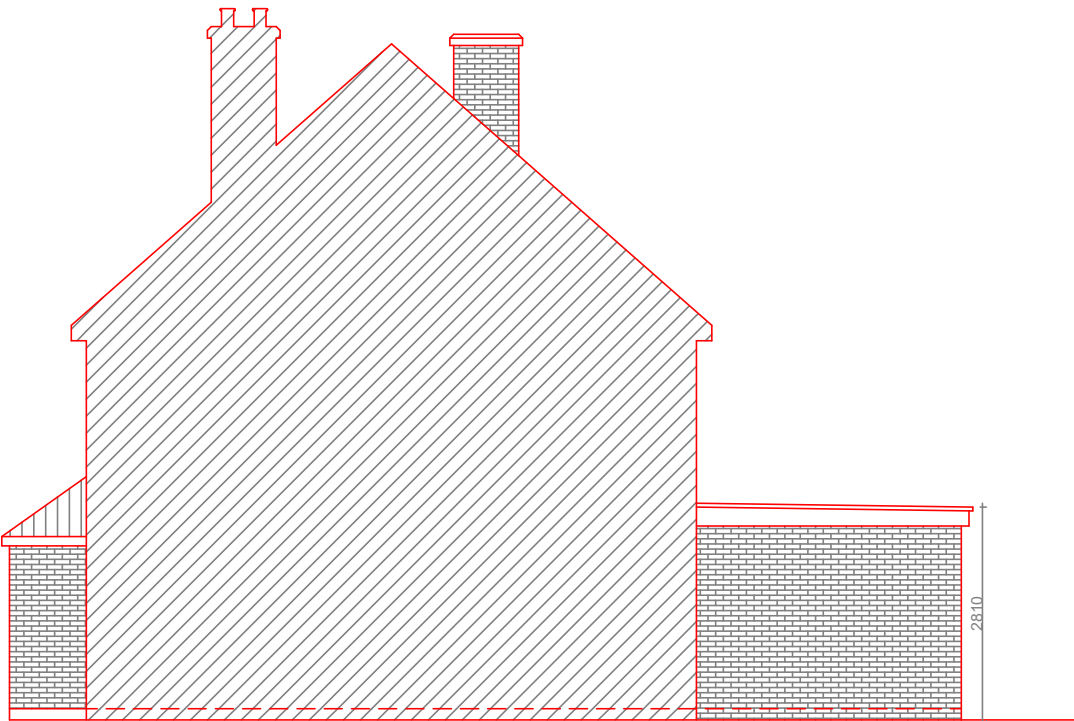

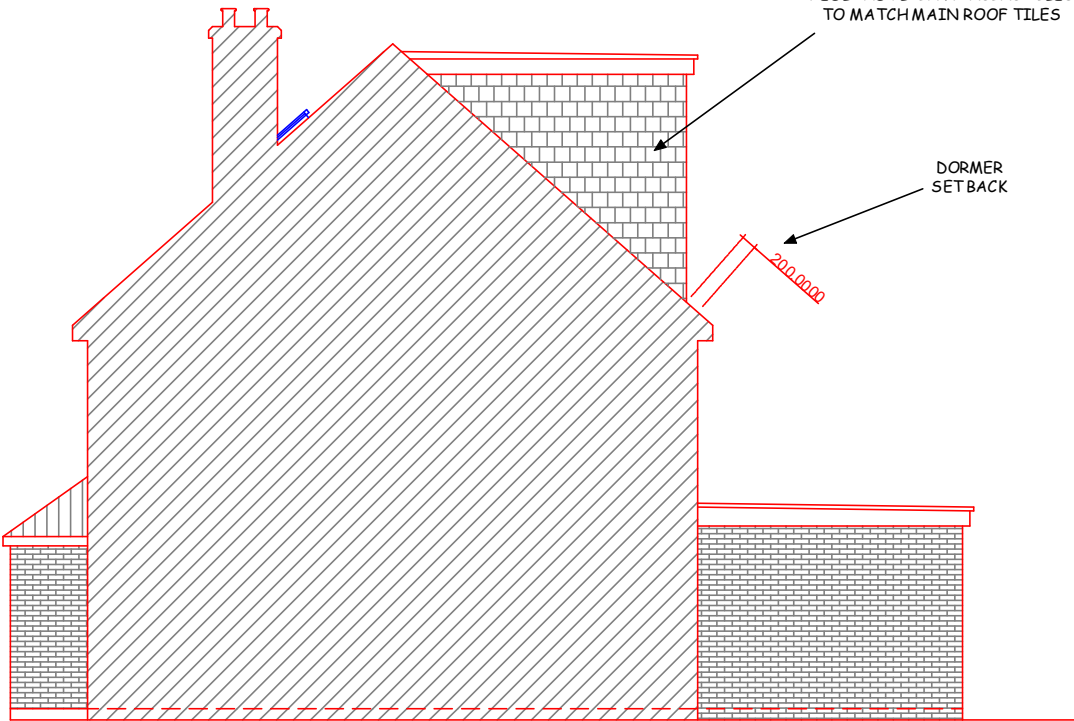

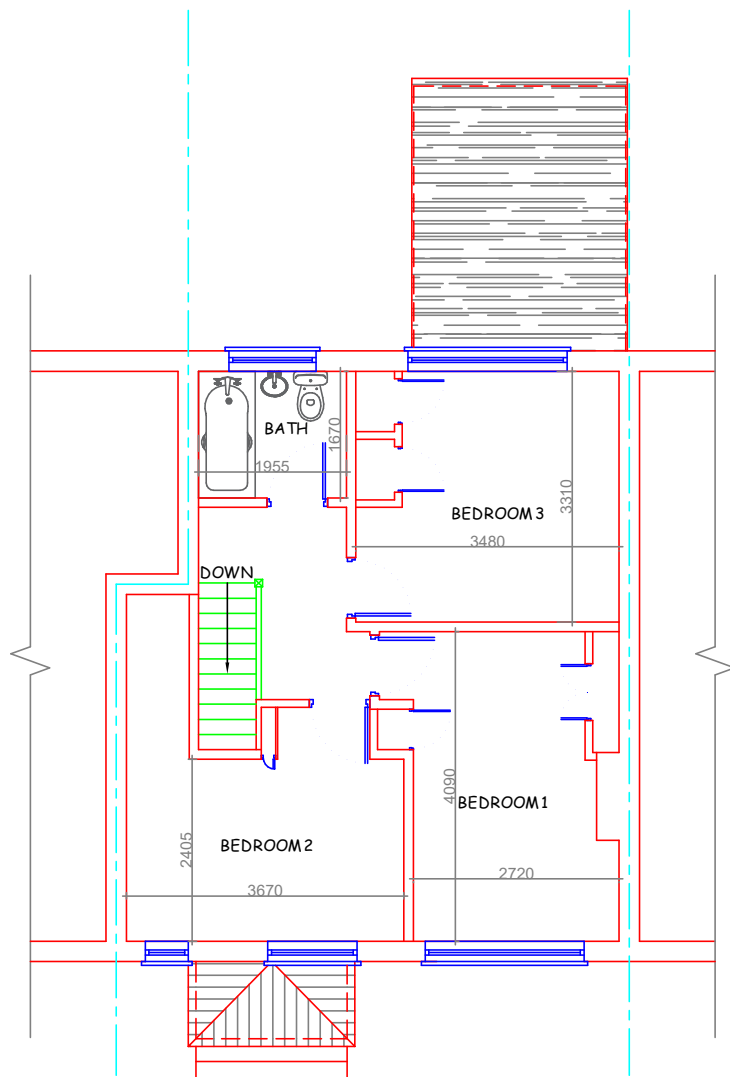


EXISTING GROUND FLOOR
PLAN

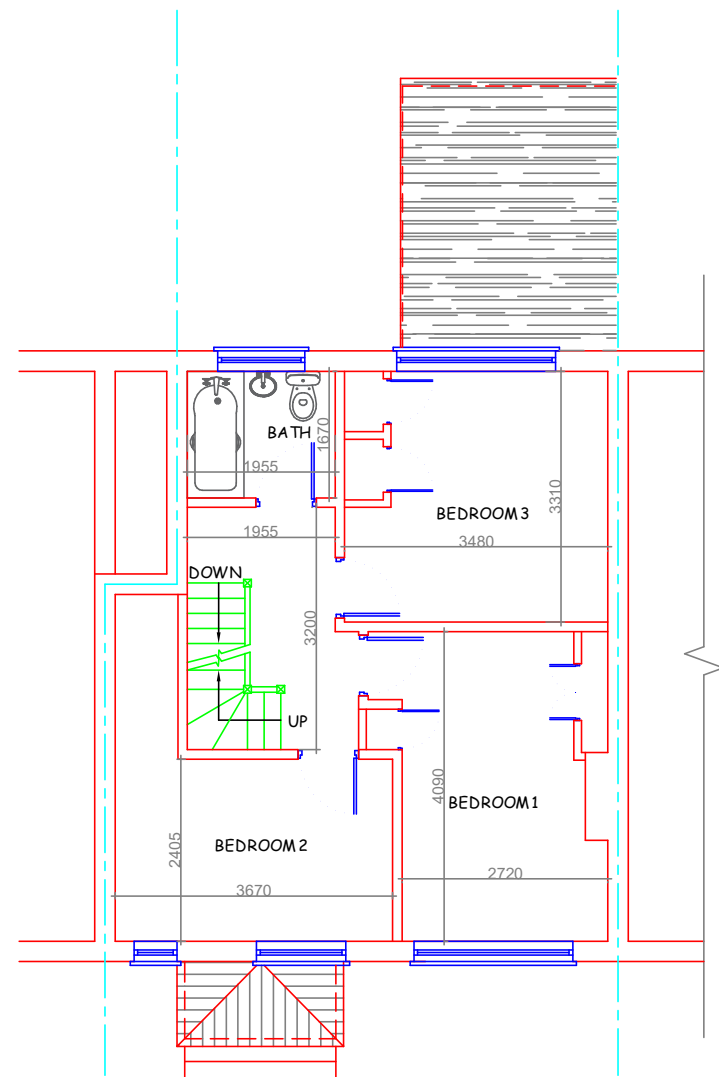


PROPOSED GROUND FLOOR

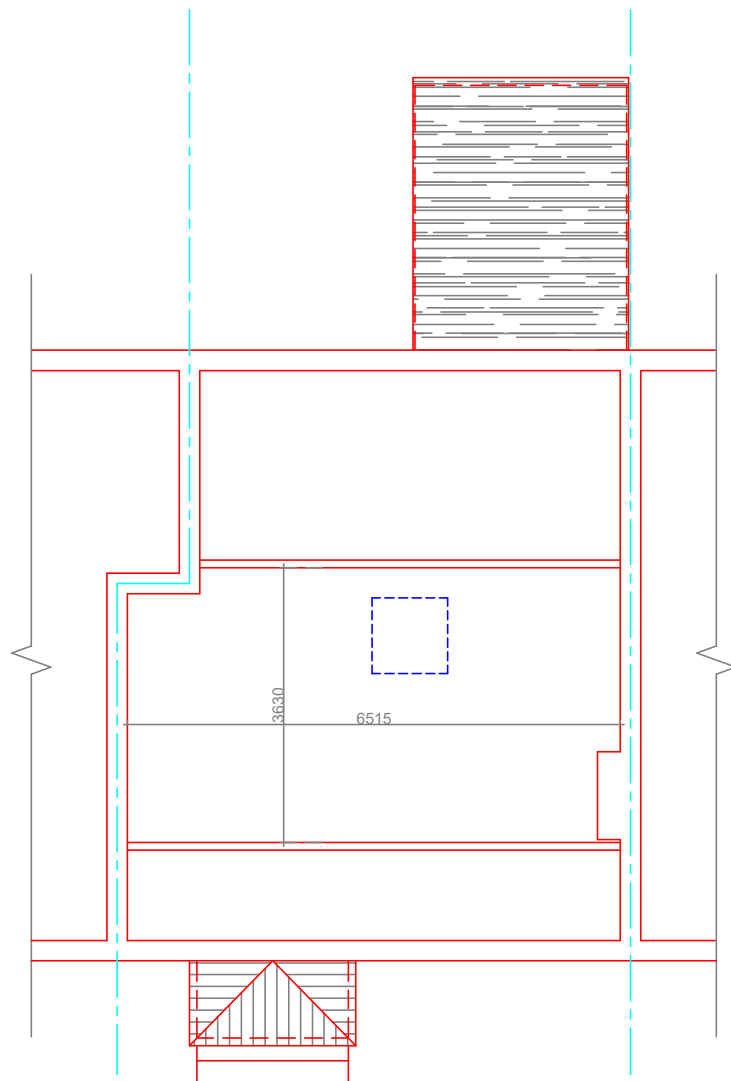


EXISTING FIRST FLOOR PLAN

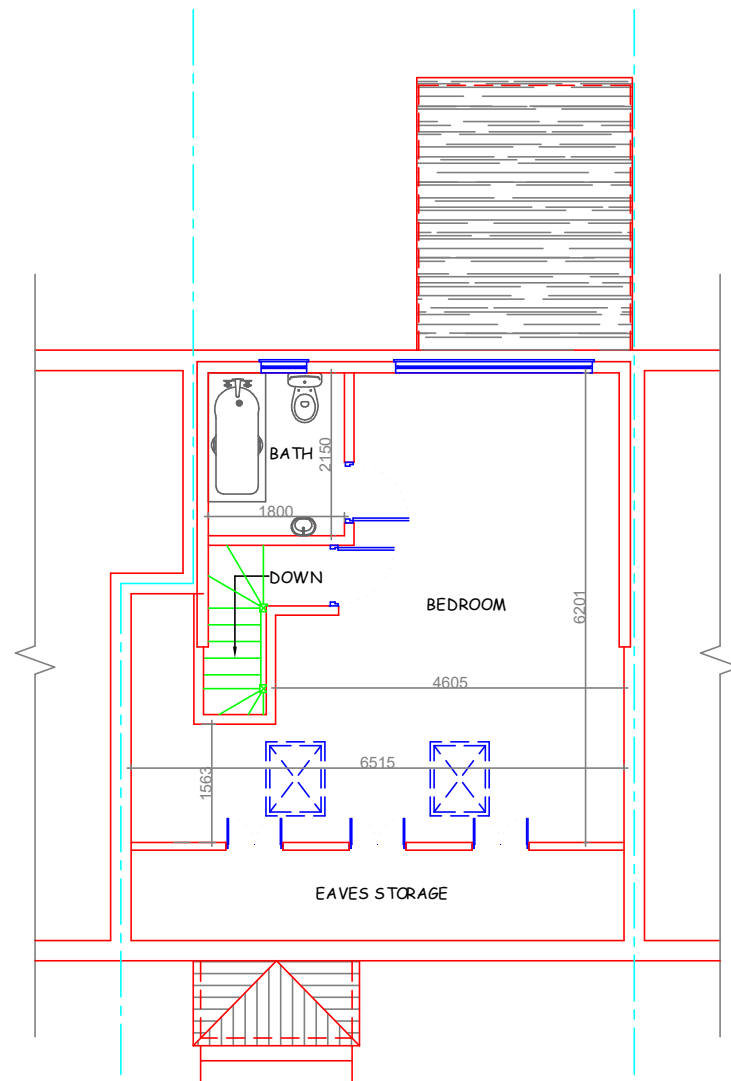


PROPOSED FIRST FLOOR PLAN

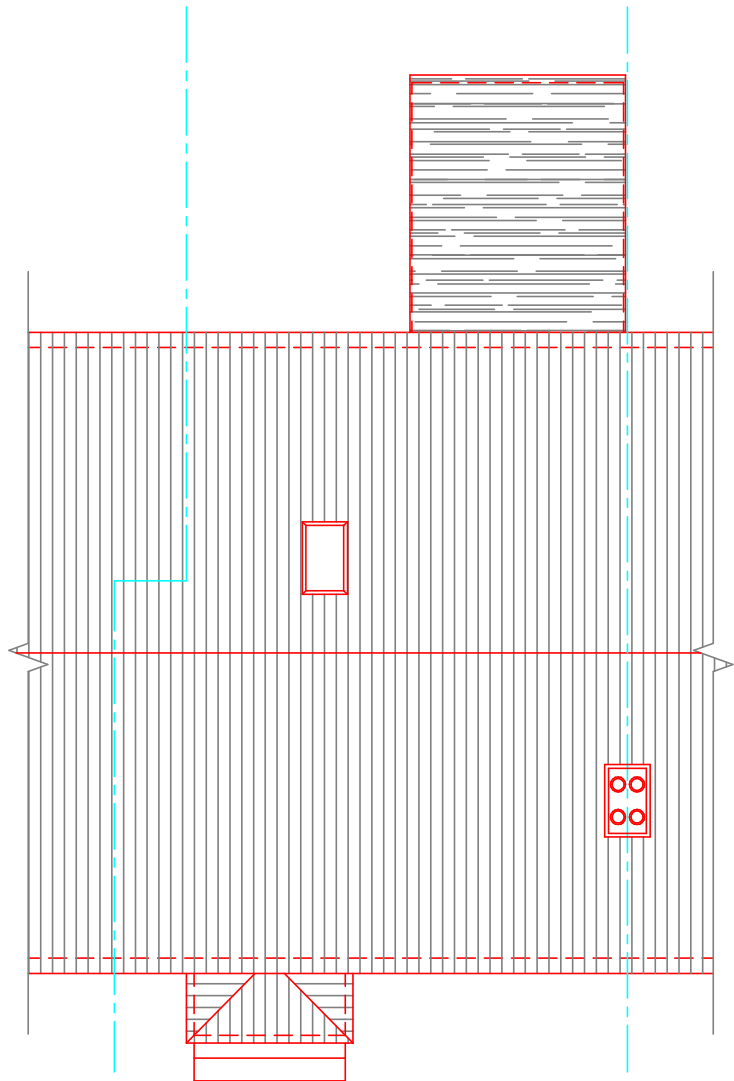


EXISTING LOFT FLOOR PLAN

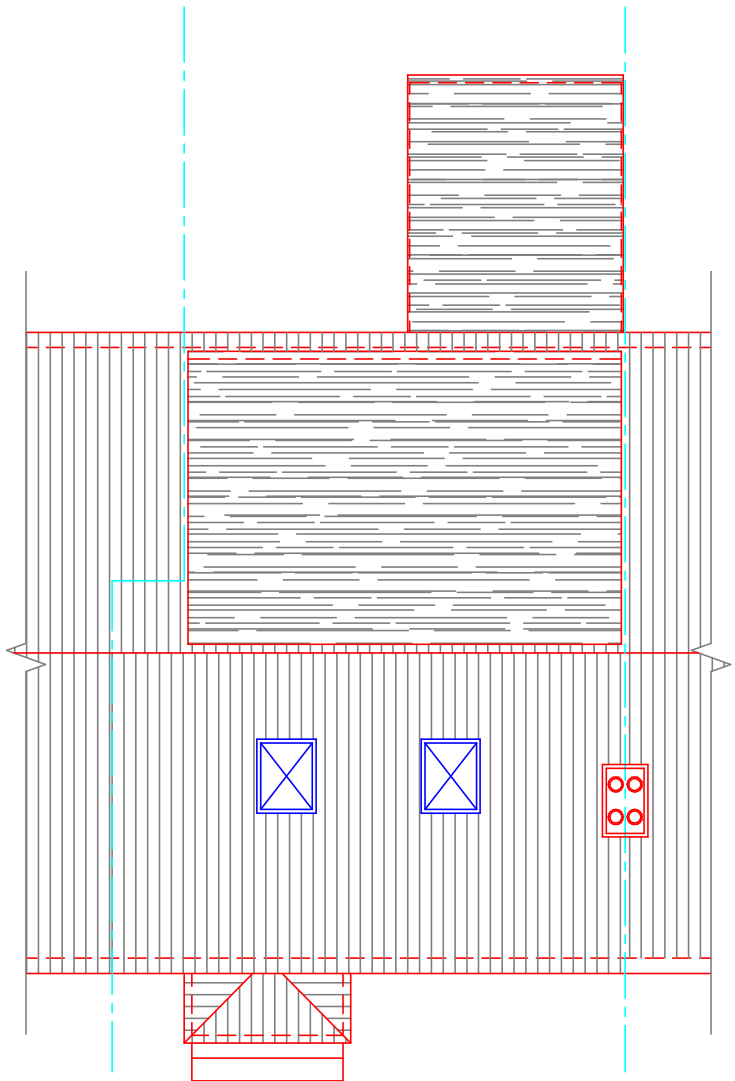


PROPOSED LOFT FLOOR PLAN
