The volume of the proposed loft conversion is less than 40m<sup>3</sup>. The works will not extend above the existing ridge on the main front elevation. All works are within the curtilage of the property. The face of the walls over the pitched roofs to be set back minimum of 200mm from the eaves. Therefore, the proposal falls within the permitted development (PD). All material to be in keeping with existing structure.
