Description of Proposed Works, Impacts and Risks

We wish to change the use of the original building (shown in attached documents) only from agriculture storage to Class use E (commercial/business/service).

Nothing structurally will be changed to the building.

The change to use E (commercial/business/service) will have no impact on the residential area.

We are a small family farm looking to diversify to increase revenue.

Currently the building is used to store farm equipment and equestrian supplies. We wish to rent the building for commercial/business/service(Class use E)

This is not a new development but a change of use of a current agricultural Barn to Class use E for which we wish to advertise it as.

Use Class E – Commercial, Business and Service –

Use, or part use, for all or any of the following purposes—

- a) for the display or retail sale of goods, other than hot food, principally to visiting members of the public,
- b) for the sale of food and drink principally to visiting members of the public where consumption of that food and drink is mostly undertaken on the premises,
- c) for the provision of the following kinds of services principally to visiting members of the public—
 - (i) financial services,
 - (ii) professional services (other than health or medical services), or
 - (iii) any other services which it is appropriate to provide in a commercial, business or service locality,
- d) for indoor sport, recreation or fitness, not involving motorised vehicles or firearms, principally to visiting members of the public,
- e) for the provision of medical or health services, principally to visiting members of the public, except the use of premises attached to the residence of the consultant or practitioner,
- f) for a creche, day nursery or day centre, not including a residential use, principally to visiting members of the public,
- g) for—
 - (i) an office to carry out any operational or administrative functions,
 - (ii) the research and development of products or processes, or
 - (iii) any industrial process, being a use, which can be carried out in any residential area without detriment to the amenity of that area by reason of noise, vibration, smell, fumes, smoke, soot, ash, dust or grit.

This will be a change of use for the Barn (shown in attached documents) only not the entirety of Manor Farm.

There will be no increase of traffic to the building than there is currently.

Building will be insulated to increase the thermal efficiency and sound insulation, this will then reduce any noise from inside the unit.

No changes will be made to the outside of the building.

Business work following the change of use will be within the unit and will be carried out Monday-Friday 7am-5pm, Saturday 8-2pm and no work Sundays.

It is only the nature of the use of the building that will change.
