Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The oak tree is located as shown in the attached diagram. It is seriously unbalanced with the branches growing in one direction towards the houses (Nos 22 & 23). The growth has been particularly vigorous in the past 3 years or so. The tree is 4 metres from the house (No22) and less than 3 meters from the drains of No 22, also very close to the drains of No 23 Ravenswood Park. Owners are concerned about damage to drains which are dangerously close to the tree and could affect the drains of several houses in the block of houses (Nos 20 to 26). The patios of both houses above the roots of the tree have become uneven. The recent growth has resulted in excessive shading, especially to No 22. The works proposed are to take 1 metre off the top of the tree, crown reduction and cutting back branches to previous points. The undersigned consulted with a tree surgeon regarding description of the work proposed. Regarding ownership the tree is jointly owned by No 22 & 23 with a larger part on the land of the property at No 22. No 23 has agreed to work proposed.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
