Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 Ash. Tag 0055. G.Fungus located at the base of the stem. Recommend a pollard at 9m from base, at good growth points.

T2 Oak. Tag 0051. Lower canopy overhanging public pathway. Crown lift to 3m and major deadwood removal.

T3 Swedish Whitebeam. Branches touching building. Crown reduction away from building, reducing multiple tertiary branches by up to 2m from tips.

T4 Lime. Branches over hanging public pathway and touching building. Crown lift to 3m and crown reduction away from building, reducing multiple tertiary branches by 2m from tips.

T5 Oak. Lower canopy blocking light from street light. Crown lift to 3m above ground level, major deadwood removal and reduction of lower canopy growing under street light. Reducing only the tertiary branches within 2m of street light.

T6 Lime. Located in the rear garden of Gloucester house. Crown lift to 3m above ground level to give clearance to pedestrians and maintenance staff.

T15 Horse Chestnut. Large cavity 2.5 from base of stem. High risk of failure. Fall line towards 12 Burbridge Gardens. Recommend pollard 6m from base at good growth points to reduce risk of tree falling on building.

T16 Swedish Whitebeam. Fungus located at the base of tree. 50% of canopy dead. Remove and replace tree.

G1 11x Lime. Lower canopies overhanging public pathway and close to building. Recommend crown lifts all canopies to 3m above ground level and crown reduction away from building, cutting multiple tertiary branches by up to 2m from tips to give 2m clearance of building.

G2 3x Lime. Lower branches overhanging public pathway. Crown lift to 3m above ground level.

G3 6x Lime. Lower branches growing over public pathway and touching building. Recommend 3m crown lift to all canopies and crown reduction on building side of trees, cutting branches by up to 2m from tips to give clearance to building.

G4 4x Sycamore. Multiple cavities within canopy. Trees historically pollarded. Trees bordering residential gardens.

Re-pollard trees at previous pollard points.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
