Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T7 Horse Chestnut. Located on front lawan of Giles Crescent. Large cavity and rot at the base of canopy. Reccomend
T8 Horse Chestnut. Tag 1255. Crown lift to 3m above ground level to give clearance to large vehicles.
T9 Oak. Large cavity with rot at base of stem and second large cavity with rot, 4.5m from base of stem. Fall line over pathway and towards building. High risk of failure. Recommend removal and plant replacement.
T10 Yew. Large tear out at base base. Rot present at base. High risk of failure. Remove and plant replace.
T11 Yew. Twinned stemmed. Large, deep cavity in one stem. Sparse canopy. Recommend heavy crown reduction, cutting branches by up to 3m from tips.
T12 Sycamore. Large G.fungus at base of tree. Historically pollarded. Recommend re-pollard at previous cut points.
T13 Maple. Heavily leaning over road and pathway. Ivy growing up 7m from base. Unstable root plate. Remove and replace tree.
T14 lime. Located at back of residential gardens. Lapsed pollard. Re-pollard at previous pollard points, to reduce risk of snapouts.
G4 4x Sycamore. Multiple cavities within canopy. Trees bordering residential gardens. Pollard trees at 12m from base of stem.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
