THESE WORKS ARE FROM A SURVEY OF GIBSON ROAD AND COVER MULTIPLE HOUSES AS SET OUT BELOW

Side of 72 Thornhill Road (T1) Oak - Raise the crown to 5.5 meters and remove the deadwood
Side of 72 Thornhill Road (T2) Oak in decline - Reduce the height to the crown break
House Number 3 (T3) Eucalyptus in rear garden - Clear the structure by 2 meters
House Number 4 (T4) Cherry in rear garden - Raise the crown to 3 meters
House Number 11 (T5) Oak in rear garden - Raise the crown to 5 meters and remove the deadwood
House Number 11 (T6) Ash x 2 in rear - Fell the right hand side tree as it is in decline and remove the deadwood from the left hand side tree
House Number 11 (T7+T8) - 2x Dead Ash in rear - Fell to ground level
House Number 11 (T9) Oak in front garden - Raise the crown to 5 meters and remove the deadwood
House Number 12 (T10) Pear in front garden - Remove the deadwood and clear the structure by 2 meters
House Number 13 (T11) - Cherry in front garden - Remove the deadwood and raise the crown to 3 meters
House Number 13 (T12) Oak in rear garden - Remove the deadwood and raise the crown to 5 meters.
House Number 25 (T13) Ash Group historically pollarded - Re-pollard to previous points approx 20ft of regrowth
House Number 27 (T14) Ash in rear garden in decline - Fell to ground level
House Number 42 (T15) Ash to side of 42 in decline - Fell to ground level
House Number 55 (T16) Apple in front garden - Fell to ground level
House Number 55 (T17) Oak in rear garden - Raise the crown to 4 meters

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

e.g. Oak (T3) – Whole crown reduction to 12m above ground level, to provide sufficient clearance to property.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
