T18 - Sycamore Tree- reduce by 15% all over approximately 3 meters all the way around, as the client made the application for the same request more than 2 years ago as they had a money problem, they did not do the tree work but would like to do it now, as the tree needs maintenance.

  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
