Details of the pre-application advice received

- Reduce the height of the building.
- Create a pathway to the garden and cycling storages.
- Set in on the rear sides to reduce bulkiness and comply with the 45 degree rule.
- Maintain traditional style architecture.

Following our pre-application meeting with Niamh McMenamin on February 23rd, we collaborated on certain amendments for further review. Despite our persistent efforts in submitting revised drawings and multiple follow-up emails, we received a response from Niamh on March 18th indicating that she is awaiting updated comments from the urban design officer. She mentioned that upon receipt of these comments, she would be in a position to issue the pre-application report, targeting the week commencing April 8th. However, despite our subsequent inquiries, we have not received any updates since then. Unfortunately, we have yet to receive the initial pre-application report or any comments on the revised drawings.

Due to our client's time constraints, we can no longer delay. Therefore, we are proceeding with submitting a full planning application using the latest drawings we sent to the case officer following the meeting. Although we have not yet received her written report or comments on the amended design, we believe that this proposal should be successful, as we have incorporated all the points discussed in the meeting.
