11 Larkswood Rise, Eastcote, Pinner, HA5 2HH

Hillingdon have an Article 4 Direction in place across the whole Borough, this restricts single storey rear extensions to a maximum 4 metres depth, unlike the 6m or 8m allowed in other authorities. This means a 6 metre deep rear extension will require full planning permission.

Policy DMHD 1 of the design policies restricts the depth of rear extensions to detached properties to 4 metres. The proposed 6 metres will exceed this and therefore have to be considered on its merits. The adjoining property at number 10 Larkswood Rise is set further back, so the extension should not affect amenity. You would need to check if number 11 has a side-facing window onto the proposed extension, if this was the sole window for a bedroom or primary room, the loss of outlook could be a reason for refusal. Overall appearance and impact of the extension on the rear of number 11 is important, it may be that 6 metres would be considered too deep in line with Policy DMHD 1.

You would need to submit an application or pre-application with plans to see how it goes. Fall-back situation would probably be an extension 4.9 metres deep in line with the existing rear projection, I would think that would be acceptable.
