#### **OPTION 1**

Service - Section dismantle

Work Required - Section dismantle tree to near ground level and leave stump in ground

Reason - tree has become a safety concern as recently two large limbs have failed without any evidential cause, one limb completely failed narrowly missing client and the other has broken and precariously hanging over footpath, these limb failures have left a significant hole within the canopy of the tree presenting the remaining limbs to new exposures potential heightening the risk for further failure. The top 2m of the tree is dead which could indicate root damage/decay which questions the trees overall stability

Priority Code - U (not going ahead)

#### **OPTION 2**

Service - Section dismantle and grind

Work Required - Section dismantle tree and Grind out the stump to a minimum of 200mm below the stump's current ground level and leave all stump arising as in-fill. Please note in-fill stump arisings will be mounded and be left above ground level to allow for settling

Reason - tree has become a safety concern as recently two large limbs have failed without any evidential cause, one limb completely failed narrowly missing client and the other has broken and precariously hanging over footpath, these limb failures have left a significant hole within the canopy of the tree presenting the remaining limbs to new exposures potential heightening the risk for further failure. The top 2m of the tree is dead which could indicate root damage/decay which questions the trees overall stability

  - showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
