This is a four-bedroom house spanning in two levels and has the potential to be converted into nine spacious HMO rooms, each meeting adequate size requirements. This involves a change of use from a residential property (C3) to a House in Multiple Occupation (HMO, C4) accommodation, featuring shared facilities such as three bathrooms & toilets, an additional toilet, and a large shared kitchen. The property is suitable for university students, hospital workers, airport employees, and other professionals in Hillingdon Borough and its vicinity.

In recent years, the property has shown signs of wear and tear. The windows are single-glazed and in poor condition, ceilings exhibit signs of leakage, and the bathrooms are outdated and unhygienic. Therefore, comprehensive refurbishment work is underway, including attention to electrical wiring, plumbing, roofing, and replacement of missing roof tiles. The initial phase of refurbishment commenced at the end of January 2024
