The condition of a replacement tree is all about replacing the amenity lost to that area when the original tree was removed. For this reason we request a front garden tree is replaced with a tree in the front garden. We would not accept a replacement within a nearby park or rear garden.

Having checked these properties both appear to have driveways for one car already, and there appears to be space to expand these driveways whilst retaining some space for a replacement tree.
