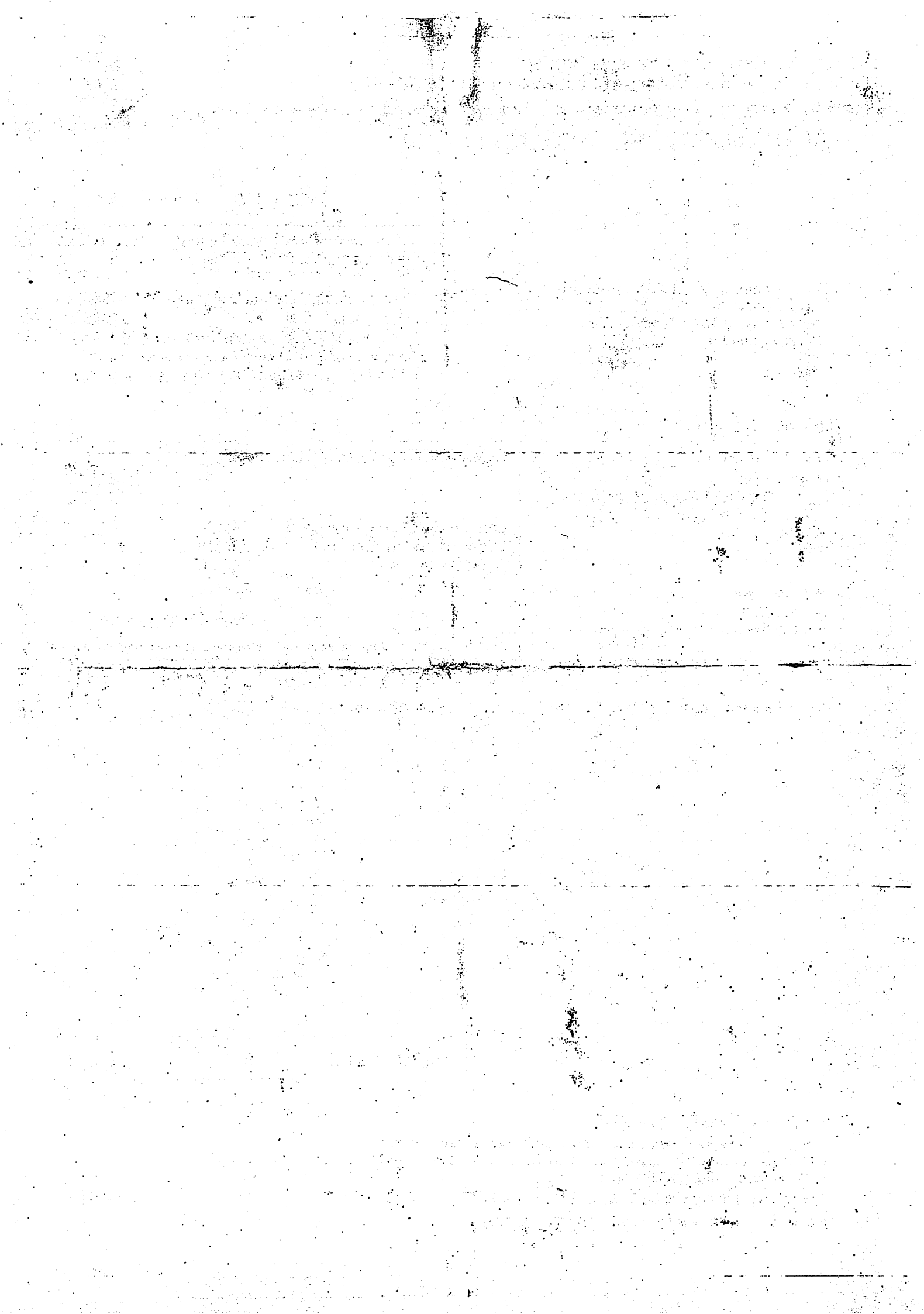

Important information about your bill

The full council tax bill assumes that there are two adults (i.e. people aged 18 or over) living in the property. If you are the only adult living in a property the council tax may be reduced by 25%. In some cases there can be more than one adult living in the property but all but one are disregarded for council tax purposes. There are also other reductions available for unoccupied properties which are not sole or main residence of an individual.

If this bill is wrong tell us immediately; it could be that you are not liable person or you think the bill is wrong as there is incorrect discount. Making an appeal does not allow you to withhold payment of tax owing in the meantime. You are required to let the council know in writing within **21 days** of realising that you are no longer entitled to discount. A failure to do this without reasonable excuse could lead to **£70 penalty**. If your appeal is successful you will receive a refund of any overpayment.

If you are unsure whether your change of circumstances will affect any entitlement to reduction, please contact us for advice.

The council has a duty to protect public funds that administers. The council will take steps to verify information given in support of any claim, discount or exemption by matching data elsewhere within authority, or with other external bodies involved in the administration of public funds, for the prevention and detection of fraud. Applications for discounts and exemptions will be verified and subject to periodic review. The council may use third party organisations to carry out such checks, using financial and credit referencing information.
