Details of the pre-application advice received

-Principle of Change of Use:

The change of use from Class C3 (residential) to Class C2 (care home) is considered acceptable in principle, as it involves a transition from one residential use to another. This aligns with planning policy, and the proposed use is compatible with the surrounding residential character of the area.

-No Over-Concentration of Care Uses:

There is no evidence of an over-concentration of care homes in the vicinity of 25 Gledwood Crescent, which supports the proposal and reduces concerns about the impact on the local area.

-Local Amenities:

The site benefits from its proximity to local shops, community facilities, and a pharmacy, which will be advantageous for both residents and staff. This ensures that essential services are easily accessible, enhancing the quality of life for future residents.

-Cycle Parking:

The provision of one cycle parking space at the rear of the property, accessible via side access, has been deemed adequate by the planning officer. This supports sustainable travel options for staff and visitors.

-Parking Provision:

The existing parking layout provides space for two cars, which is sufficient for regular staff use. The proposal does not involve any alterations to the current parking arrangement, and the site is well-served by public transport, with bus stops on Uxbridge Road within 400 metres.

-Outdoor Amenity Space:

The existing garden space is relatively small; (however, under the new proposed layout, this concern has been addressed properly. The proposed outdoor spaces are in accordance with DMHB 18 Private Outdoor Amenity Space Standards, which outline the minimum amenity space provision (sqm)). Additionally, the site's location near local parks and recreational areas offers further opportunities for outdoor activities, enhancing the overall amenities for future residents.

Supporting Documents:

In line with the pre-application advice, the following documents will be submitted to support the planning application:

-Site Location Plan, Block Plan, Existing and Proposed Floor plans (including roof plans), Existing and Proposed Elevations, Operational Management Plan (detailing the nature of care, staff numbers, working hours, and visitor/manager parking arrangements)

The pre-application advice has been instrumental in shaping the proposal, and the positive aspects highlighted above demonstrate that the development is well-considered and responsive to local planning policies. The submission will address the officer's concerns, particularly regarding the operational management plan and accessibility, to ensure the proposal meets the needs of future residents and the surrounding community.
