The red line boundary for the Willow Lawn toilet block is situated along the western edge of the reservoir, while the Woody Bay red line boundary is located on the southern edge, adjacent to the Woodlands Centre (postcode HA4 7TX). The red line boundary for the location of the PVS is the resident's car park located just the the north of the Willow Lawn site.
