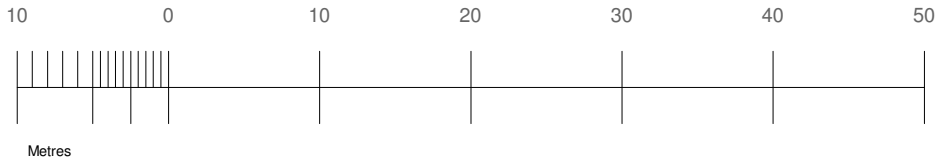


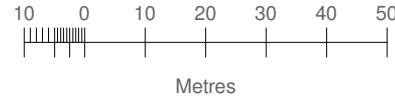

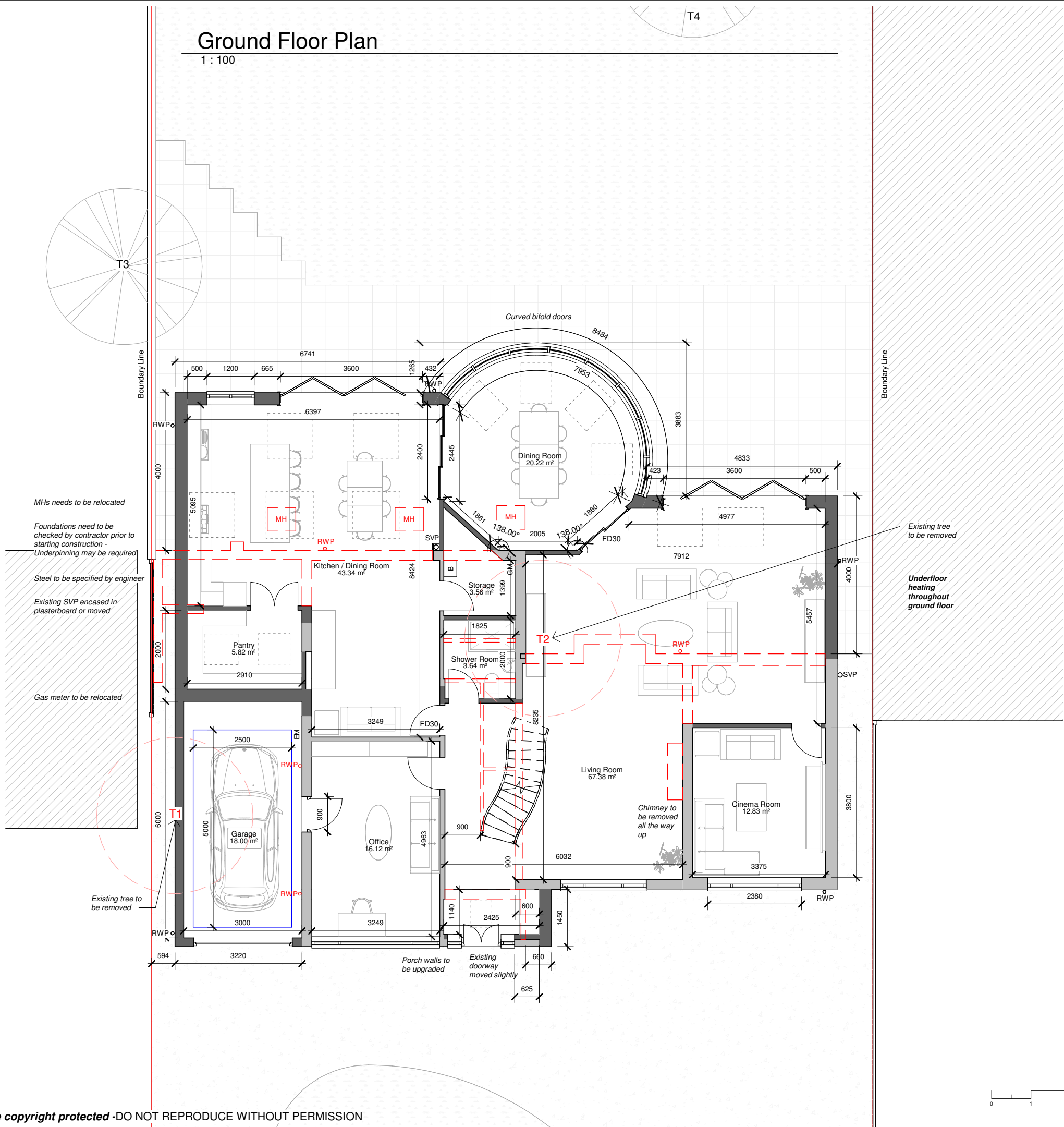
SITE PLAN_ LOCATION MAP

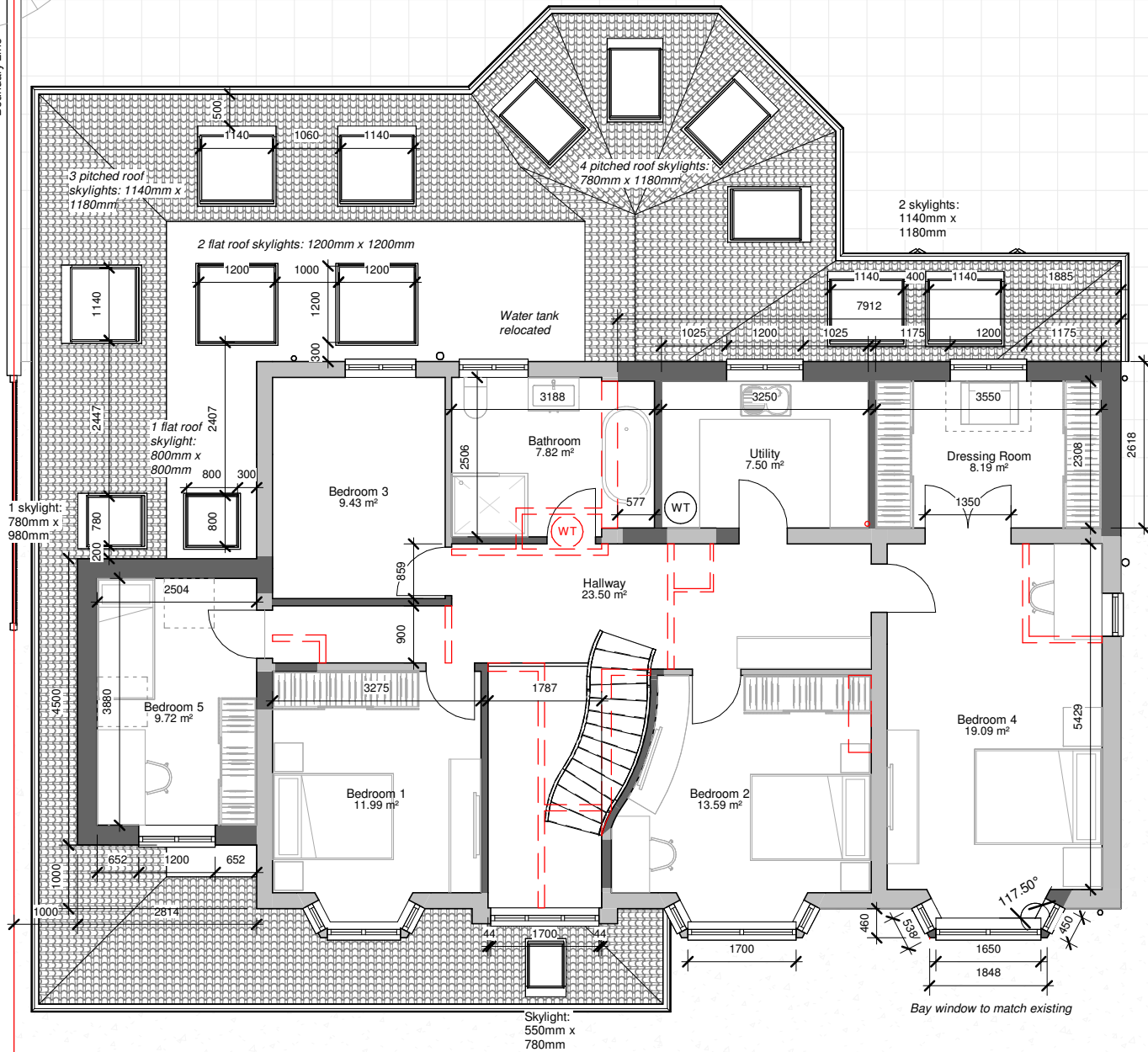

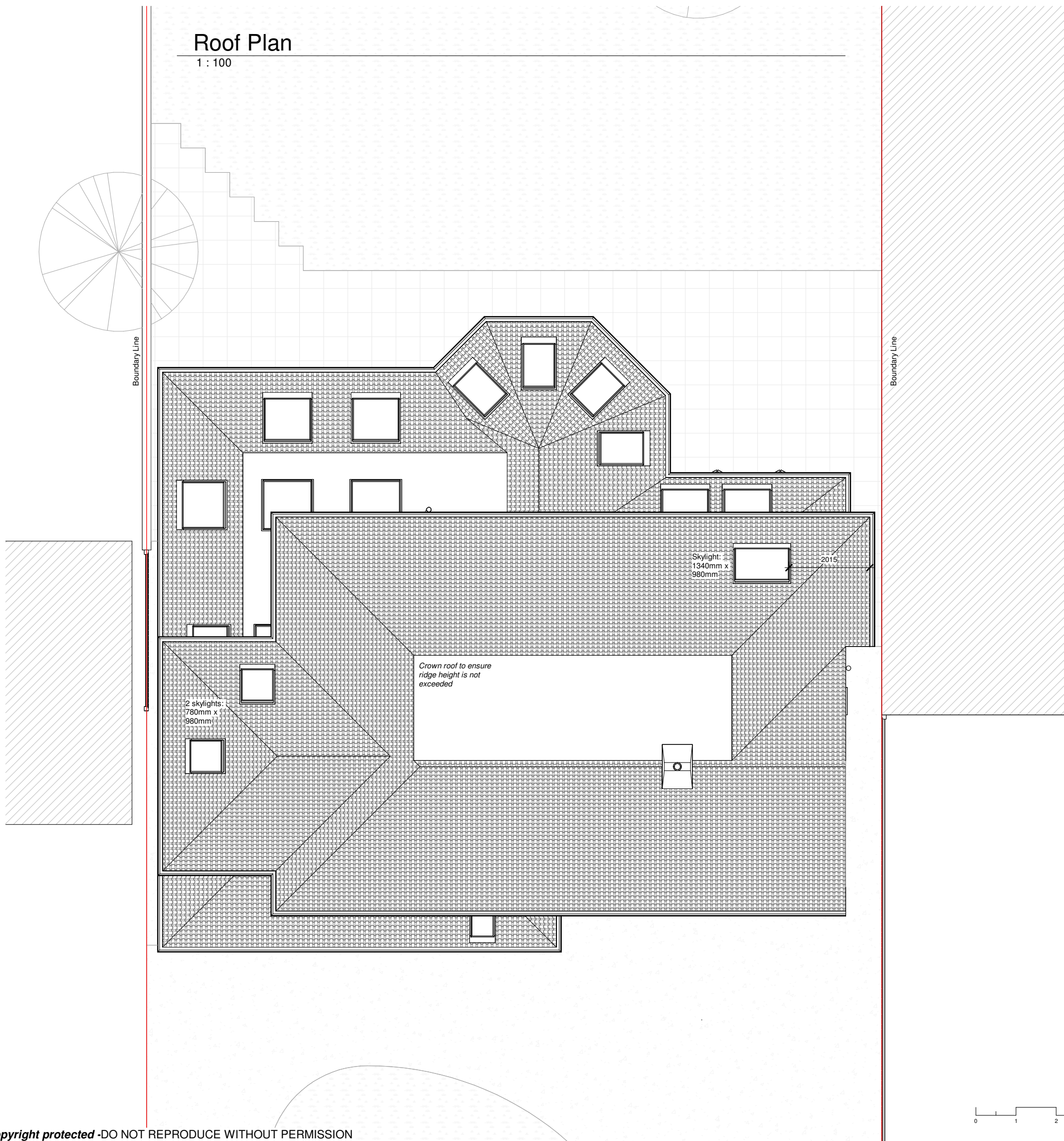

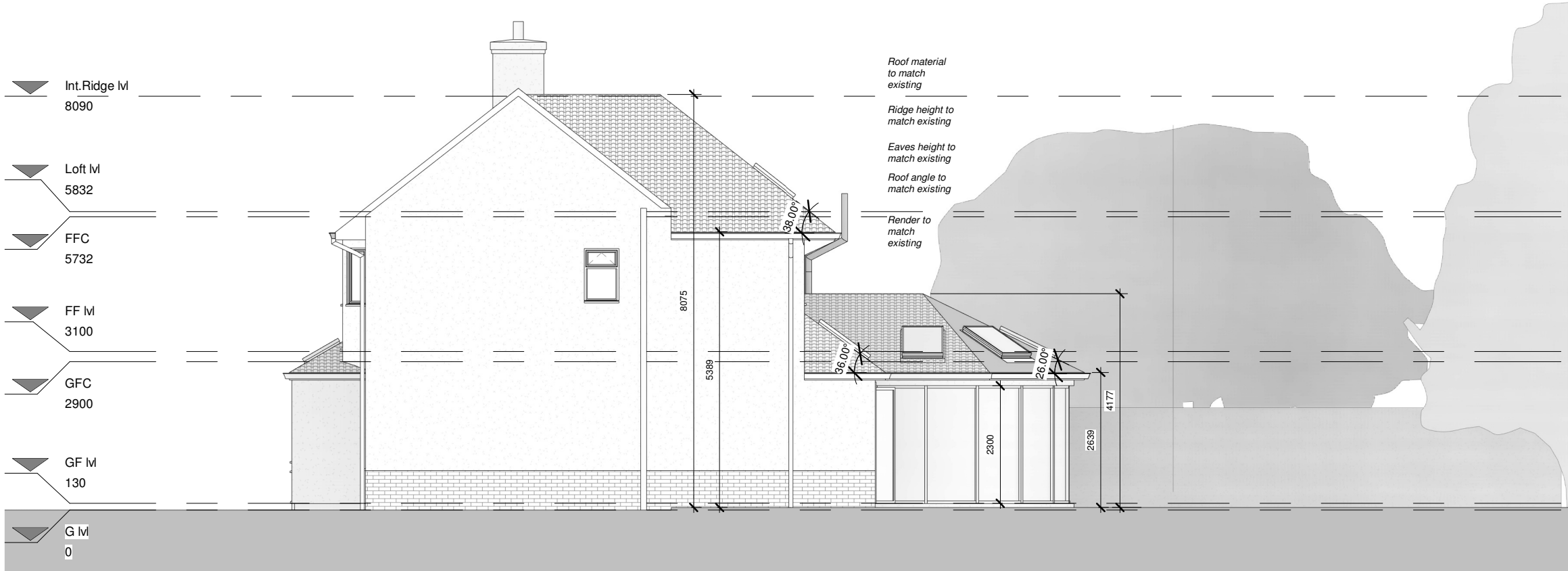
Rear Elevation
