Existing materials and finishes:

The existing front external wall is comprised of red brickwork below the brickwork band, with pebbledash above. The rest of the existing property features pebbledash to all external walls.

Proposed materials and finishes:

The proposed scheme will retain the existing red brickwork below the brickwork band to the existing front elevation, and introduce a new, matching, band and brickwork across front, side and rear of double-storey side extension, as well as to the rear elevation of the main house. Above the brickwork band, the existing pebbledash is to be removed and replaced with a white rendered finish. The new single-storey rear extension is to have white rendered walls.

Existing materials and finishes:

The existing property features red clay roof tiles to the main house, and a felt roof to the existing side extension.

Proposed materials and finishes:

The proposed property will retain the existing red clay roof tiles, and the new section of roof over the double-storey side extension will feature red clay tiles to match the original existing. The new single-storey rear extension roof will also feature red clay tiles to match the main house.

Existing materials and finishes:

The existing property features a mix of white, double-glazed UPVC windows and white single-glazed aluminium sliding doors to the main house, as well as single-glazed timber doors and windows to the existing side extension.

Proposed materials and finishes:

The proposed property is to feature slate grey, triple-glazed UPVC windows to the main house, double-storey side extension, and single-storey rear extension. Velux skylights are also proposed to front and rear roof slope over the main house, and to the roof of the rear extension.
