Details of the pre-application advice received

Conclusion:

The application site comprises a two storey detached dwelling situated on the north easterly side of Northgate, Northwood occupying the corner plot on the junction with Ducks Hill Road. The application site benefits from an area of hardstanding for off street parking, an area of soft landscaping and a rear garden, accessible via the side of the dwelling.

The pre-application seeks advice regarding the erection of a part single, part two storey extension to the front, side and rear of the dwelling. Conversion of roof space to habitable use including front and rear dormers, raising of the existing ridgeline. Installation of a new dropped kerb, extension to existing dropped kerb and erection of a new detached garage.

In terms of design, concerns relate to the size, scale and design of the front extension and front facing gable end windows which would not be considered minor alterations to the front elevation of the dwelling, and would be considered out of character within the surrounding street scene and Area of Special Local Character. In addition there would be concerns with the proposed roof form, particularly relating to the proposed front dormers which would not accord with policy and would be out of character within the surrounding street scene and Area of Special Local Character.

There are also concerns relating to the size, scale and siting of the proposed double garage, and it is recommended that the siting and scale is rethought within a future planning application. In addition, a future planning application should include an Arboricultural Impact Assessment in order to confirm there would be no loss or harm to protected trees within the application site.

Given the above considerations, the current proposal, would be unlikely to be viewed favourably within a future planning application and the above concerns would need to be addressed in order to increase likelihood of a favourable decision being made as part of any forthcoming planning application submission.
