Tree Type - 2x Hazel (*Corylus avellana*)

Approx. Height - 7m

Approx. Crown Spread Diameter - 5m

Location - Right hand boundary

Service - Pollard

Work Required - Establish both groups of stems as a 'high pollard' at around 5.5m (just below gutter height) and remove the basal epicormic shoots to tidy.

Reason - To manage size and reduce encroachment over adjacent property and gutters.

Priority Code - on

Tree Number - T2 - Option 1

Tree Type - Honey Locust (*Gleditsia tricanthos*)

Approx. Diameter at 1.5m - 20cm

Approx. Height - 9m

Approx. Crown Spread Diameter - 6m

Location - Right hand boundary, Rear garden

Service - Crown Reduction

Work Required - Reduce height by up to 1.5m and lateral spread on all sides by up to 1m, pruning to suitable growth points/branch fork junctions.

Reason - To maintain clearance from house while retaining best form and balance.

Priority Code - on

Tree number - T3

Tree type - Lilac (*Syringae* sp.)

Approx Height - 5m

Location - Rear garden, Right hand boundary

Service - Prune

Work required- Prune north-west side of crown back by around 0.5m

Reason - to maintain clearance from building

Priority code - on

Tree Number - T4

Tree Type - Yew (*Taxus baccata*)

Approx. Height - 5-6m

Location - Rear garden, Right hand boundary (overhanging from adjacent garden)

Service - Trim

Work Required - Trim clients side hard back as possible without losing green foliage cover.

Reason - To reduce encroachment/debris over property.

Priority Code - on

Tree Number - T5

Tree Type - Paperbark Birch (*Betula papyrifera*)

Approx. Diameter at 1.5m - 20cm

Approx. Height - 8m

Approx. Crown Spread Diameter - 7m

Location - Rear garden, Left hand boundary

Service - Crown Reduction

Work Required - Reduce height by around 1.5m and lateral growth by around 1m, pruning to suitable growth points.

Reason - To maintain best compact form and give clearance to house/neighbours garden.

Priority Code - on

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
