The proposed development adheres to the Permitted development rights for householders Technical Guidance: B1.(d) The cubic content of the resulting roof space would not exceed the cubic content allowance of the original roof space by more than 40 cubic meters. Our proposal includes a loft conversion with the addition of a dormer. The dormer volume is 11.28 cubic meters. B.2(a) The materials used in any exterior work shall be of a similar appearance to those used in the construction of the exterior of the existing dwellinghouse. Our proposed dormer has similar materials to the original dwellinghouse. Thus a Lawful Development Certificate should be granted for this proposal.
