I would suggest a CLD for the ground floor rear conservatory extension (it looks to be 3m (d)) and porch, and a planning application for the first floor rear balcony enclosure element (similar to 24s-50276/APP/2014/488)).

The CLD will eliminate the need for a tree survey as the site is covered by TPO 2.

Recessing the front door wouldn't require planning permission in my opinion.
