Description of Proposed Works

Please describe the proposed single-storey rear extension

The proposal comprises a single storey brick clad rear extension extending 3.6m beyond the rear of the existing building as it has stood since it was first built. The extension will feature a flat roof (membrane at max 3m along adjoining site boundaries) with a parapet coping construction around the perimeter (at ~3.3m max) and a rooflight near the rear of the existing 1st floor external wall. The rooflight will extend higher than the parapet construction, but will certainly not extend more than 3.4m in overall height from ground level.
