3 neighbouring properties were consulted on the application by letter dated 14-05-25. The consultation period expired 05-06-25. No representations have been received.

5. MAIN PLANNING ISSUES

The main considerations are the design and impact on the character of the existing property, the impact upon the streetscene and locality the impact upon the amenities of adjoining occupiers, the reduction in size of the rear garden, and car parking provision.

Character and Appearance:

The Hillingdon Local Plan: Part One Strategic Policy BE1 seeks a quality of design in all new development that enhances and contributes to the area in terms of form, scale and materials; is appropriate to the identity and context of the townscape; and would improve the quality of the public realm and respect local character.

Policy DMHB 11 of the Hillingdon Local Plan: Part Two - Development Management Policies (2020) advises that all development will be required to be designed to the highest standards and incorporate principles of good design. It should take into account aspects including the scale of the development considering the height, mass and bulk of adjacent structures; building plot sizes and established street patterns; building lines and streetscape rhythm and landscaping. It should also not have an adversary impact on the amenity, daylight and sunlight of adjacent properties and open space.

Policy DMHD 1 requires that alterations and extension of dwellings would not have an adverse cumulative impact on the character and appearance of the street scene, and should appear subordinate to the main dwelling. It also required that there is no unacceptable loss of outlook to neighbouring occupiers.

With regard to rear extensions, Policy DMHD 1 states:

- i) single storey rear extensions on terraced or semi-detached houses with a plot width of 5 metres or less should not exceed 3.3 metres in depth or 3.6 metres where the plot width is 5 metres or more;
- ii) single storey rear extensions to detached houses with a plot width of 5 metres or more should not exceed 4.0 metres in depth;
- iii) flat roofed single storey extensions should not exceed 3.0 metres in height and any pitched or sloping roofs should not exceed 3.4 metres in height, measured from ground level;
- iv) in Conservation Areas and Areas of Special Local Character, flat roofed single storey extensions will be expected to be finished with a parapet;
- v) balconies or access to flat roofs which result in loss of privacy to nearby dwellings or gardens will not be permitted;

With regard to side extensions, Policy DMHD 1 states:

- i) side extensions should not exceed half the width of the original property;
- ii) extensions to corner plots should ensure that the openness of the area is maintained and the return building line is not exceeded;
- iii) garages should reflect the size guidelines set out in Appendix C Parking standards;

The proposed development involves the erection of a single storey side and rear wrap around extension. The rear element would measure 3.6m in depth and a maximum height of 3.4m sloping to an eaves height of 2.5m. The side extension would measure 2m in width, 11.8m in depth (connecting with the rear extension) and be characterised with a pitched roof. It would be sited along the side boundary and would be set back from the existing front porch. Although sited directly along the side boundary it is not considered to harm the character and appearance of the surrounding area. It is not considered to create a terracing effect as the development is at single storey level only and sufficient separation would remain at first floor level between the two sets of semi-detached properties. The rear extension is modest in depth and is not considered to harm the character and appearance of the host property nor the surrounding area.

The development would involve the reduction of size of existing rear store to facilitate the development. This is not considered to cause harm to the character and appearance of the surrounding area or original property.

Impact on residential amenity:

Policy DMHD 1 states that alterations and extensions of dwellings will be required to ensure that a satisfactory relationship with adjacent dwellings is achieved

Policy DMHB 11 of the Hillingdon Local Plan: Part Two - Development Management Policies (2020) states that development proposals should not adversely impact on the amenity, daylight and sunlight of adjacent properties and open space.

Number 44 Denbigh Drive is located south of the application site and forms the other half of the semi-detached properties. The proposed extension would project 3.6m deeper than the rear building line of this neighbour and it is not considered that this modest depth coupled with the sloping roof with an eaves height of 2.5m would cause a significant level of overshadowing or loss

of light. It is not considered that the development would be overbearing to this neighbour.

Number 40 Denbigh Drive is located north of the application and is separated from the host. The proposed extension would be sited along the shared boundary with this neighbour. It is noted that this neighbour has ground floor side facing windows that serve a kitchen which would face the proposed extension. A kitchen is not considered as a habitable room and as such the light levels are not required to be protected. It is considered that there would be a loss of light to this room however as explained above as this is a non-habitable room this is considered on balance acceptable. It should also be noted that a side extension of this width without the wrap around element could be built out under permitted development. There would be no windows facing this neighbour and as such there would be no loss of privacy or overlooking.

On balance, the proposed development would have an acceptable impact on the neighbouring properties.

External Amenity Space:

Approx. 48sqm of rear garden would be retained excluding the outbuilding structures. table 5.3 of Policy DMHB 18 requires 3 bedroom properties to have a minimum of 60sqm of private garden space. It is acknowledged that the resultant garden would fall under this, however it is not considered to be significantly harmful to the amenities of current and future occupiers to warrant refusal alone.

Parking and Highway Safety:

The proposed development would not affect the existing parking arrangement at the site. It is therefore considered that the proposal would not significantly exacerbate the demand for street parking or prejudice highway safety, in accordance with DMT 6 of the Hillingdon Local Plan: Part Two - Development Management Policies (2020).

Conclusion:

The application is recommended for approval, subject to conditions.

6. RECOMMENDATION

3. HO4 Materials

The materials to be used in the construction of the external surfaces of the development hereby permitted shall match those used in the existing building and shall thereafter be retained as such.

REASON

To safeguard the visual amenities of the area and to ensure that the proposed development does not have an adverse effect upon the appearance of the existing building in accordance with Policy DMHB 11 of the Hillingdon Local Plan Part 2 (2020)

4. HO5 No additional windows or doors

Notwithstanding the provisions of the Town and Country Planning (General Permitted Development) Order 2015 (as amended) (or any order revoking and re-enacting that Order with or without modification), no additional windows, doors or other openings shall be constructed in the walls of the development hereby approved facing numbers 40 and 44 Denbigh Drive

REASON

To prevent overlooking to adjoining properties in accordance with policy DMHB 11 of the Hillingdon Local Plan Part 2 (2020).

5. RES14 Outbuildings and extensions

Notwithstanding the provisions of the Town and Country Planning (General Permitted Development)(England) Order 2015 (or any order revoking and re-enacting that Order with or without modification); no garage(s), shed(s) or other outbuilding(s), nor extension shall be erected without the grant of further specific permission from the Local Planning Authority.

REASON

To protect the character and appearance of the area and amenity of residential occupiers in accordance with policies DMHB 11 and DMHD 2 of the Hillingdon Local Plan Part 2 (2020)

6. NONSC Removal of permitted development rights

Notwithstanding the provisions of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended) (or any Order revoking or re-enacting that Order with or without modification), the property shall be used solely as a single dwellinghouse (Use Class C3), and no change of use to a House in Multiple Occupation (Use Class C4) shall take place without the prior written planning permission of the Local Planning Authority.

REASON

To protect the character and appearance of the area and amenity of residential occupiers in accordance with policies DMHB 11 of the Hillingdon Local Plan Part 2 (2020)

INFORMATIVES

1. On this decision notice policies from the Councils Local Plan: Part 1 - Strategic Policies appear first, then relevant Local Plan Part 2 (2020), then London Plan Policies (2016). Hillingdon's Full Council adopted the Hillingdon Local Plan: Part 1 - Strategic Policies on 8 November 2012 and the Hillingdon Local Plan Part 2 on 16 January 2020.
2. The Council will recover from the applicant the cost of highway and footway repairs, including damage to grass verges.

Care should be taken during the building works hereby approved to ensure no damage occurs to the verge or footpaths during construction. Vehicles delivering materials to this development shall not override or cause damage to the public footway. Any damage will require to be made good to the satisfaction of the Council and at the applicant's expense.
