This application seeks approval for the conversion of the existing loft space into habitable accommodation. The proposal includes the construction of a rear dormer to create additional headroom and usable floor area, along with the installation of rooflights to the front roof slope for natural light and ventilation.

The new loft space will accommodate one additional bedroom providing much-needed additional living space for the occupants without significantly altering the character or external appearance of the property.

The dormer will be finished with materials to match or complement the existing roof and external finishes of the property. The overall design has been carefully considered to be in keeping with the character of the host building and surrounding properties. The proposed works will not result in any overbearing impact, loss of privacy, or visual intrusion to neighbouring properties.

The total volume of the proposed roof extension is within the limits of permitted development i.e., not exceeding 40m³ for terraced houses and the ridge height will not be increased.

The proposal has been designed to comply with relevant planning policies and guidance and is intended to deliver a high-quality, functional space while preserving the character and appearance of the area.
