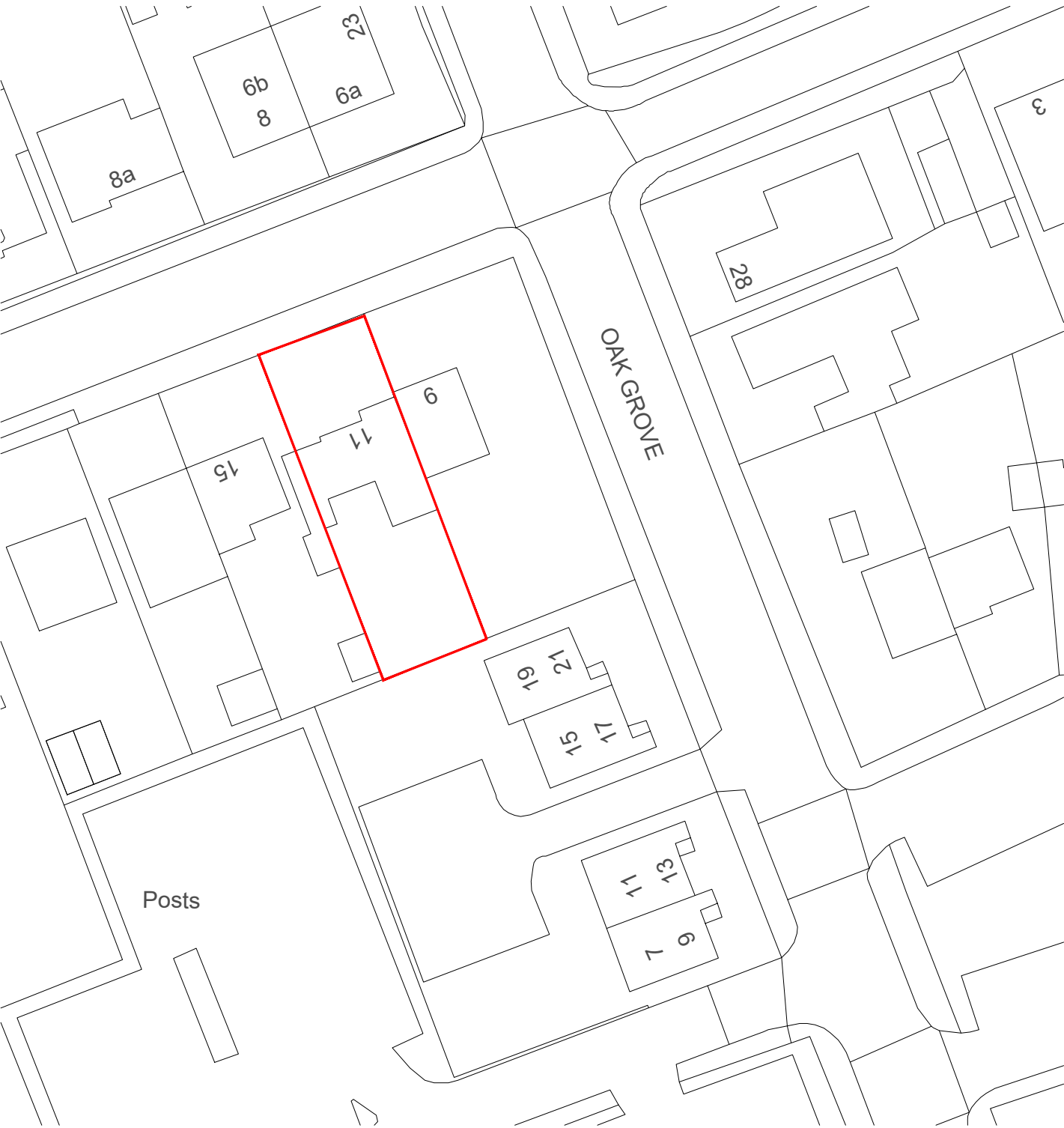
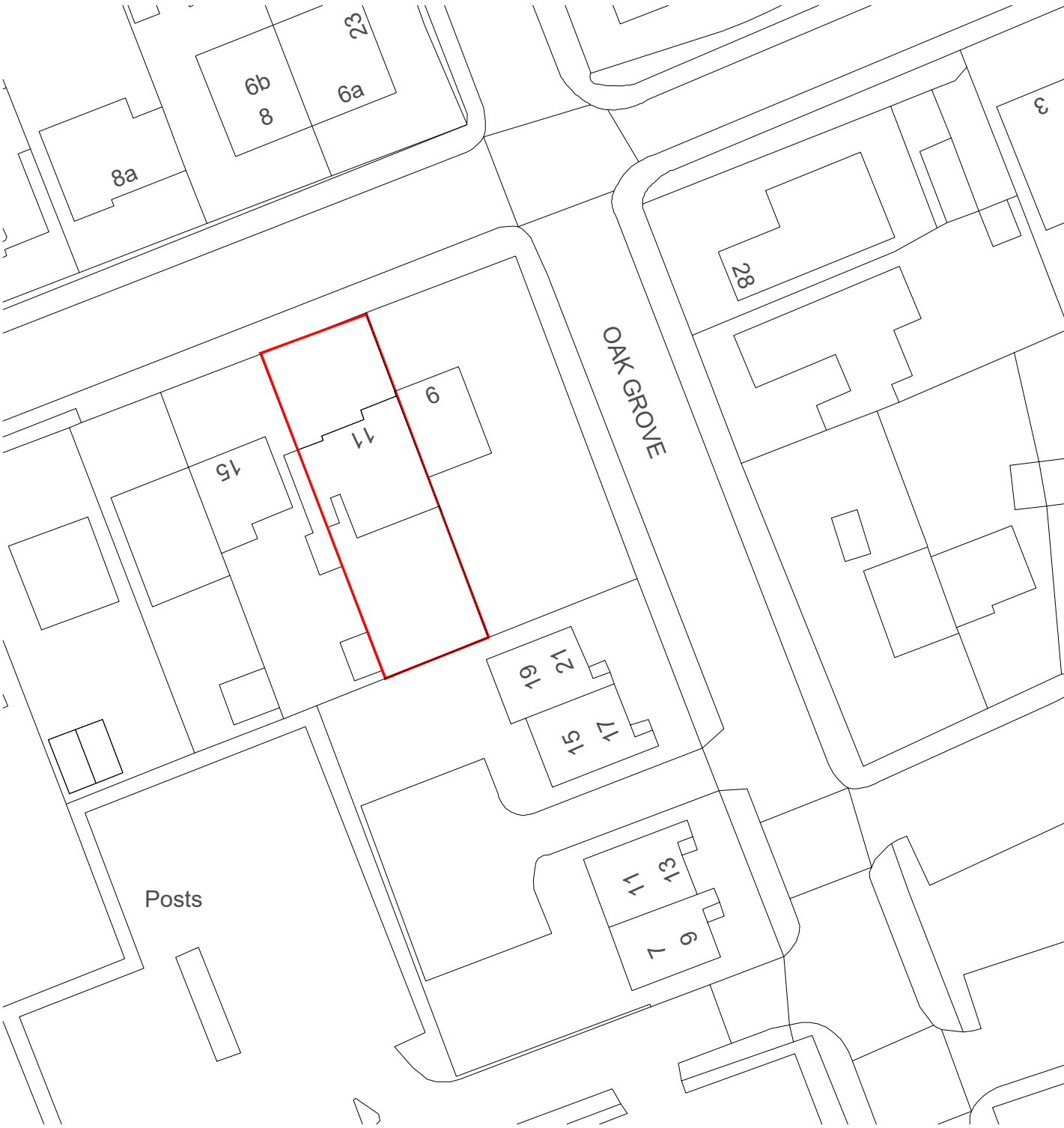

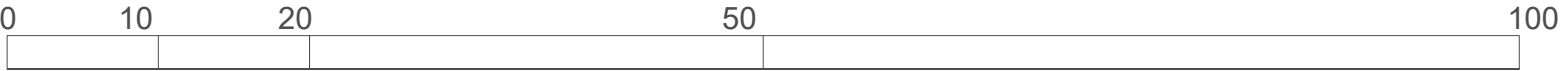


BLOCK PLAN

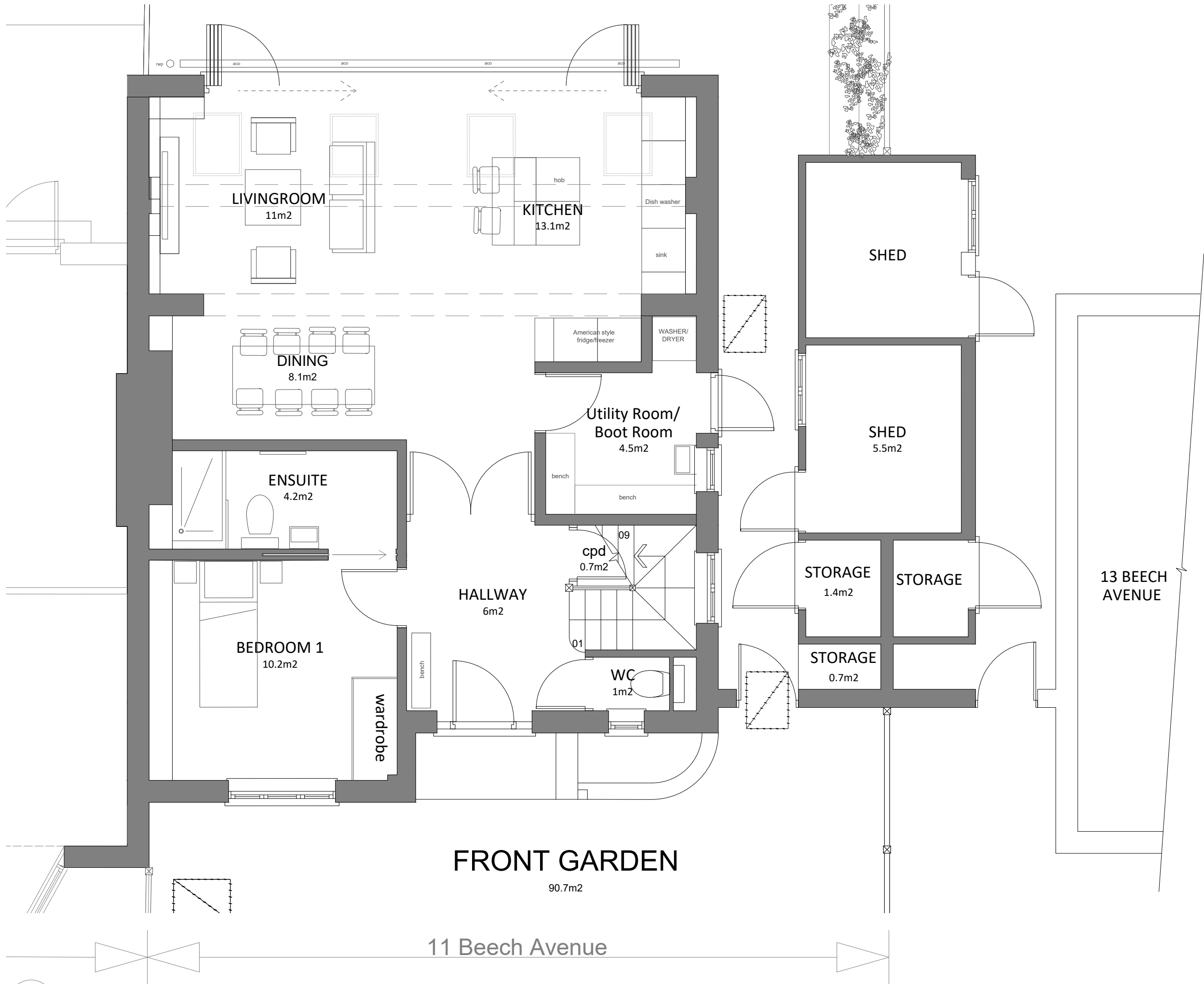
