I have two photographs showing how the oak tree is overhanging from our neighbours front garden, into our front garden, very close to our house and roof.

'Tree overhang 1' shows the overhang branches nearly touching our house.

'Tree Photo 1' shows the boundary line (yellow line)

Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Robarts Close has a beautiful oak tree in the front garden of 5 Robarts Close and we are in favour preserving it. The mature oak has a high amenity value and is making a positive contribution to the appearance of the local landscape.

But the growing size of the tree has been neglected and is now overhanging dangerously our front garden (6 Robarts Close).

Can you clarify whether we need the formal consent of Hillingdon Council for the removal of deadwood, dangerous / hanging branches and ivy, please?

We have to apply to trim the oak tree because it has overgrown branches which hang far over the boundary line of 5 Robarts Close (see photograph 'tree overhang 1' which is taken from our front driveway). Very soon the branches will hit our roof and the external walls of our house - which will damage our house, which is unacceptable.

We also have concerns that the heavy branches may fall on to our roof, house, cars and front garden in bad weather.

Our understanding is that the oak tree has not been trimmed significantly since the developer of the road, Bellway, had trimmed it, presumably with the council's approval, circa 1986.

We would like to trim the branches back to the boundary line: this is shown in the yellow line on 'Tree photo 1'.

We accept that we may have to pay a specialist tree surgeon/arborist to carry out the work. And a professional and competent arboriculturist who undertakes it should comply with the conditions of this consent and in accordance with industry best practice (BS 3998:2010).

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
