The existing use of the land is lawful as it has been continuously used as a single residential dwelling (Use Class C3) with no material change of use. The proposed side extension relates to this lawful residential use and does not alter it.

The existing building is a lawful dwellinghouse, and the proposed extension complies with the limitations set out under Class A of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended). The extension is not more than half the width of the original house, does not exceed 4 metres in height, and features a pitched roof in keeping with the character of the existing property.

Accordingly, both the existing building and the proposed works are considered lawful within the context of the residential use of the site.

A Lawful Development Certificate should be granted for this proposal because the works comply fully with the requirements of Class A of Part 1, Schedule 2 of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended).

The proposed side extension is designed to meet all relevant criteria, including:

- The extension will not exceed half the width of the original dwellinghouse.
- The overall height will not exceed 4 metres, and the roof will be pitched to match the existing house.
- The materials used will be similar in appearance to those of the existing dwelling.
- The proposal will not extend beyond a principal elevation or highway-facing side elevation.

As such, the proposal constitutes permitted development, and no planning permission is required. Therefore, it is respectfully requested that a Lawful Development Certificate be granted confirming the lawful status of the proposed works.
