Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 - Front Garden - Oak - Crown lift by 1m over the property only, thin the crown by 20% and cutback/reduce the lower canopy that is facing the building by 1.5m to suitable growth points and remove any visible deadwood/dying branches.

Reasoning for crown lift: this is to prevent branches growing close to the property and telephone wires on the lower side of the canopy in the future.

Reasoning for thin: The tree has quite a dense canopy and blocks out a large amount of sunlight, there is also a heavy amount of leaf fall over the front of the property's structure and lawn.

Reasoning for cutting back/reduction: The tree is quite large and situated close to the structure, a lot of the branches are growing either close or over the roof of the property and within time could be touching the property which can cause all sorts of problems. resident has also complained about heavy leaf fall into the gutters which cause them to be blocked and water spilling over. this has been cleared but if not tended to could cause damp in future seasons of leaf fall.

T2 - Rear Garden - Oak - Crown lift to 5m from ground level and remove all visible deadwood

Reasoning for crown lift: The tree has 2 severely low limbs facing towards the house, by lifting these 2 limbs they would be "in situ" with the rest of lower crown and also provide adequate space for the resident to use their garden without worry of an extended low hanging limb maybe snapping out.

T3 - Rear Garden - Oak - Remove all visible deadwood

T4 - Rear Garden - Ash - Remove all visible deadwood.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
