We sought pre-application advice from the London Borough of Hillingdon Planning Department (planning@hillingdon.gov.uk) prior to submitting this application. The key queries raised related to:

1. Single-Storey Rear Extension:

We proposed a ground floor rear extension and sought guidance regarding the offset from neighboring property (No. 18) in line with the Hillingdon SPG.

The Planning Information Officer confirmed that the proposed slope illustrated in our sketch successfully addresses potential impact concerns on No. 18 and deals with the offset, and there were no anticipated objections to the extension, subject to maintaining appropriate dimensions.

2. Front Off-Street Parking With Dropped Kerb:

We included a front parking space in our proposal to provide off-street parking, recognising the council's encouragement of measures to reduce street congestion.

The Planning Information Officer indicated that the parking arrangement was unlikely to attract objections, with the recommendation to retain some greenery and use permeable materials to manage surface water run-off.
