Why do you consider that a Lawful Development Certificate should be granted for this proposal?

The proposal is for a detached single-storey ancillary outbuilding within the residential curtilage of the dwellinghouse, to be used as a garage, workshop and storage incidental to the enjoyment of the dwelling.

The building will not exceed 2.5 metres in height, will be less than 50% of the curtilage garden area, and will be set back from the principal elevation of the dwellinghouse. It will not provide any sleeping accommodation and will remain incidental to the use of the dwellinghouse.

Accordingly, the proposal is considered to fall within the scope of permitted development under the General Permitted Development Order and is therefore lawful.
