The proposal involves a rear roof dormer extension to provide sufficient head height. The dormer will be constructed using materials matching the existing building, with three new roof lights to the front. The existing use of the building is a flat above a shop and remains the same. This development constitutes the use of the roof void from non-habitable storage to habitable residential use. The overall use of the building will remain a flat above a shop. The proposed works are within the cubic volume allowance for similar developments and will not exceed the height of the existing roof.
