Thank you for your enquiry and I apologise for the delay there has been in getting back to you.

I have attached a copy for you of the original permission pertaining to the construction of the property, 19 Barrington Drive.

Condition 15 of that permission removed permitted development rights at the property "for any extension". My interpretation would be that this would include extensions to the roof i.e. a loft conversion that includes dormers etc. Planning permission would therefore be required for any side link extension as inferred, or any loft conversion that involves an enlargement/expansion of the existing roof space.
