Amendments Summary

The submitted driveway dimensions were approximate. Following more accurate site measurements, the front garden is curved, with the proposed driveway depth varying from approximately 3.5m on the left to approximately 5.0m on the right. The previously stated 4.0m depth on the right was an estimate. The proposed parking space will utilise the deeper right-hand side and is intended for small family cars only, allowing the vehicle to be parked wholly within the site without overhanging the public footway.
