The change of use from Use Class C3 to Use Class C4 constituted permitted development pursuant to Schedule 2, Part 3, Class L of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended), prior to the LPA's Article 4 Direction Order in Dec 2025.

The purpose of this application is not to demonstrate ten years' immunity from enforcement action under Section 171B of the Town and Country Planning Act 1990.
