Thank you for this Technical Note which has now been considered by Alan. He advises that on balance, the Highway Authority can accept the active travel zone contribution of £15,000 towards the Santander Cycle Hire scheme as proportionate to the transport impact of the development. He also wishes to pass on his thanks for this.

I have not as yet heard back from the Air Quality Officer, but looking at their comments again, I think it is clear that the air quality mitigation contribution sought already includes a 5% reduction for the Santander Bikes but will kept trying to get this confirmed.

That just leaves the drainage issues.
