T32 - Ash - Limb has fractured and come to rest on the adjacent building, it's still connected to the main tree and is still alive, would like to remove it. Reduce / remove branch touching building above spot light. Reduce by 2/3 metres limb overhanging yew / building with wound on upper side of limb.

T34 - Ash - Sparse. Die-back in crown - Would like to Crown reduce by 4-5m all round.

T35 - Ash - Would like to Crown reduce by 6-8m all round

T36 - Western Red Cedar - Standing dead stack - Would like to reduce height by 5m

T41 - Holly - Would like to Fell

T43 - Pear - Would like to crown reduce by approx 1m

T45 - Apple - Would like to crown reduce by approx 2m

T53 - Ash - Crown and scaffold branches in a very poor condition. Tear out wounds, cankers and major deadwood noted - Would like to Pollard at 18m to manage as a smaller tree.

TG1 (T12-T30 in report) Yew Group x 22 - Would like to Crown reduction by no more than 1.5m providing clearance to out buildings by no less than 1m, and Remove all dead wood. Additional to works recommended in the report required to maintain trees in their current position so they are not intrusive over the play area and buildings.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
