G2.1 - English Elm - Remove Dead Elm

T35 - Ash - Crown reduce main stem by 6-8m and sub stem by 4-6m all around.

T36 - Western Red Cedar - Reduce in height to 3m

T43 - Common Pear - Crown reduce by 1m to form smaller rounder tree.

T49 - Holly - Remove

G56 - Common Alder, Ash, Yew - Single large dead limb, near top of Alder., Low target area, make safe. Remove major dead wood (50mm diameter and over).

With Reference to Pre-application site meeting with Tree Officer Jonathan Sandilands 25th March 2026.

As discussed on site, safeguarding concerns were raised by the school in 2020 due to the presence of Yew berries. This is particularly relevant as the site is a special educational needs school, and staff have reported incidents of pupils accessing and eating the berries and becoming unwell. The trees have been managed through regular crown reductions to try and mitigate the issue. Unfortunately, the concern remains ongoing and supervision alone cannot realistically prevent access to the berries. The school has therefore been considering a revised approach which includes a combination of limited removals, protective fencing, and ongoing management of the remaining trees.

The following works are proposed as discussed with Jonathan to address both the safeguarding concerns and the amenity value of the trees.

TG1 - English Yew x 3 - Fell (refer to annotated photo attached for clarification of which trees)

TG2 - English Yew x 15 - Crown reduce by no more than 2m (no more than 40mm cuts) over artificial lawn area to stay within new installation of anti-climb fence line.

T1 - English Yew - Reduce over extended laterals to form new crown (no more than x 2 200mm cuts).

  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
