**BACKGROUND**

Application ref: 9011/APP/2021/4365 was approved in February 2022, for the:

*"Temporary permission (5 years) for a MRI unit, including a single MRI Unit, control room, examination room, tech room and plant room and associated timber walkway to include a reporting office, cleaners store and a linen store with associated works."*

Condition 4 attached to the decision requires that:

*"Within 3 months of the date of this decision, a landscape scheme has been submitted to and approved in writing by the Local Planning Authority. The Scheme shall include: -*

1. *Details of Soft Landscaping*  
1.a *Planting plans (at not less than a scale of 1:100),*  
1.b *Written specification of planting and cultivation works to be undertaken,*  
1.c *Schedule of plants giving species, plant sizes, and proposed numbers/densities where appropriate*
2. *Details of Landscape Maintenance*

2.a *Landscape Maintenance Schedule for a minimum period of 5 years.*

2.b *Proposals for the replacement of any tree, shrub, or area of surfacing/ seeding within the landscaping scheme which dies or in the opinion of the Local Planning Authority becomes seriously damaged or diseased.*

### 3. *Schedule for Implementation*

*Thereafter the development shall be carried out and maintained in full accordance with the approved details."*

In accordance with the above, the following information is hereby submitted in line with condition 4:
