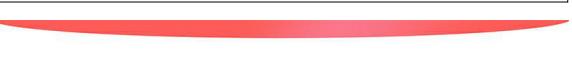


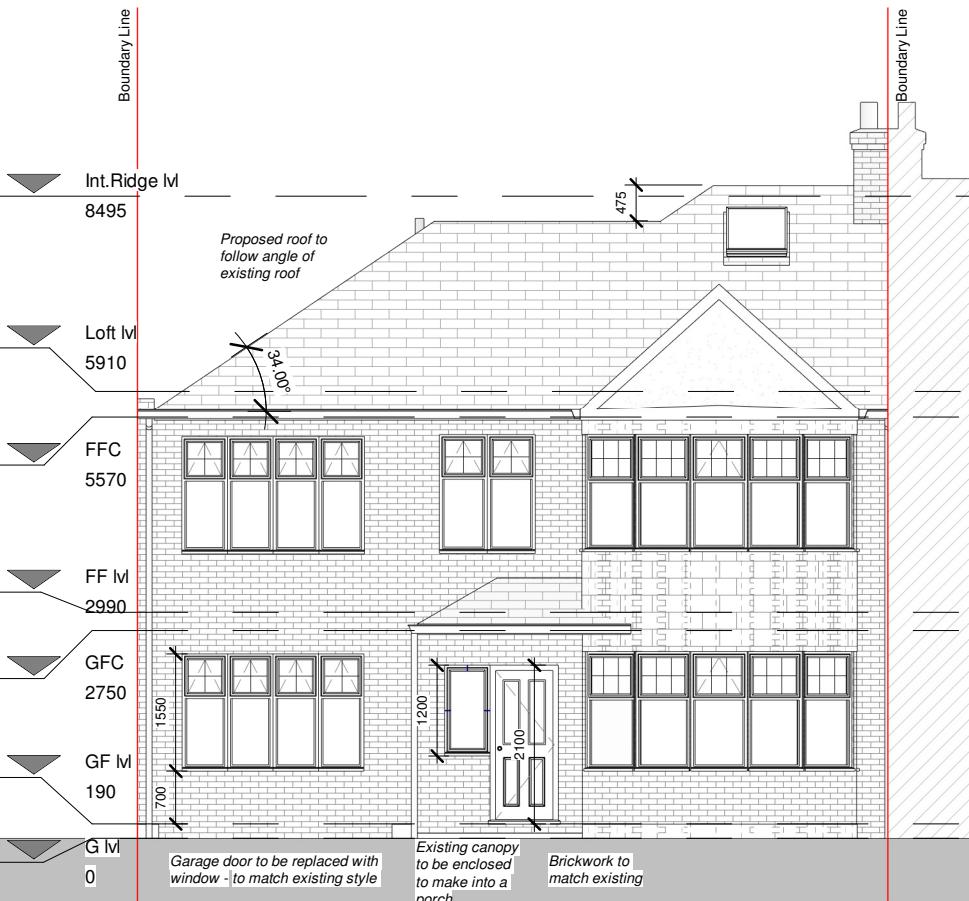

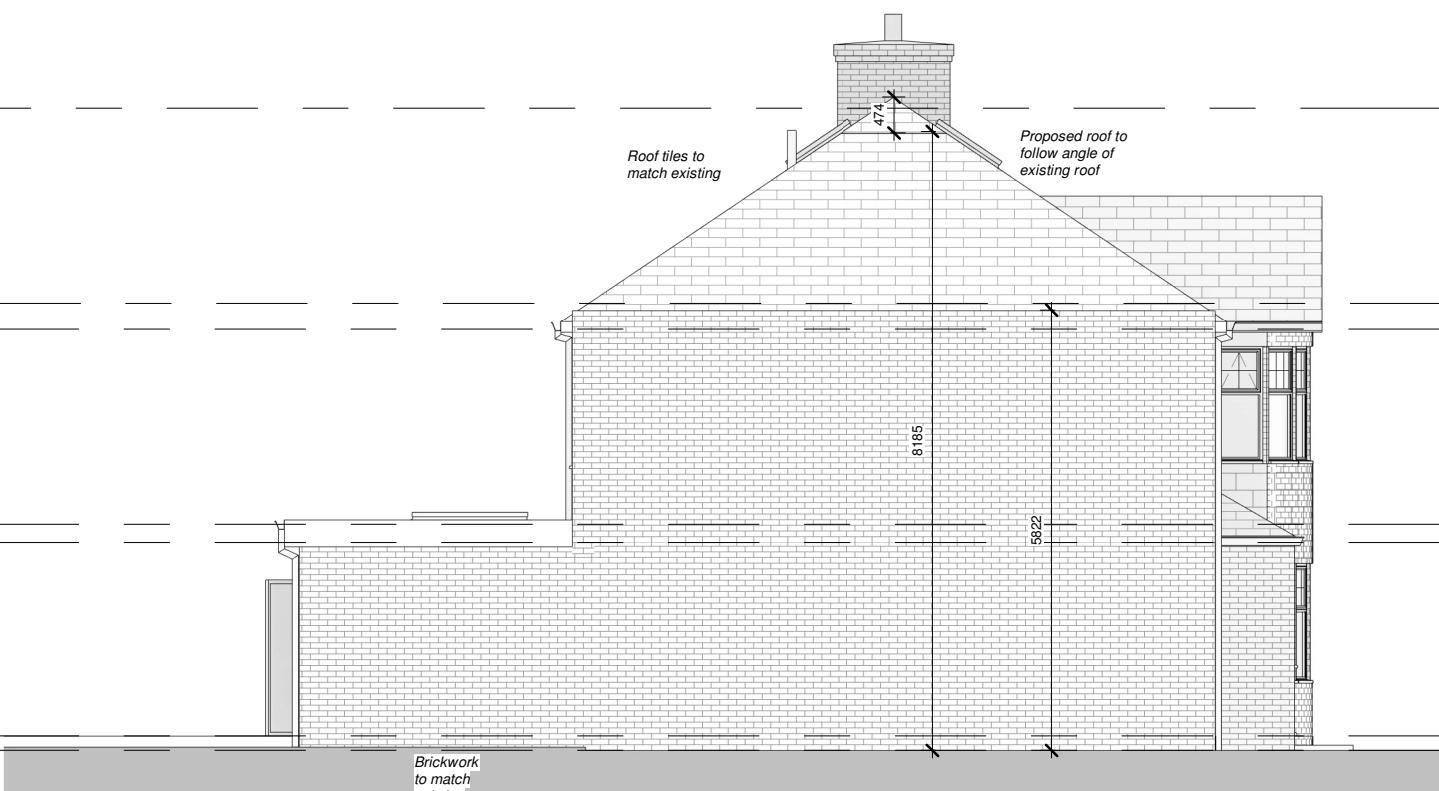
Front elevation

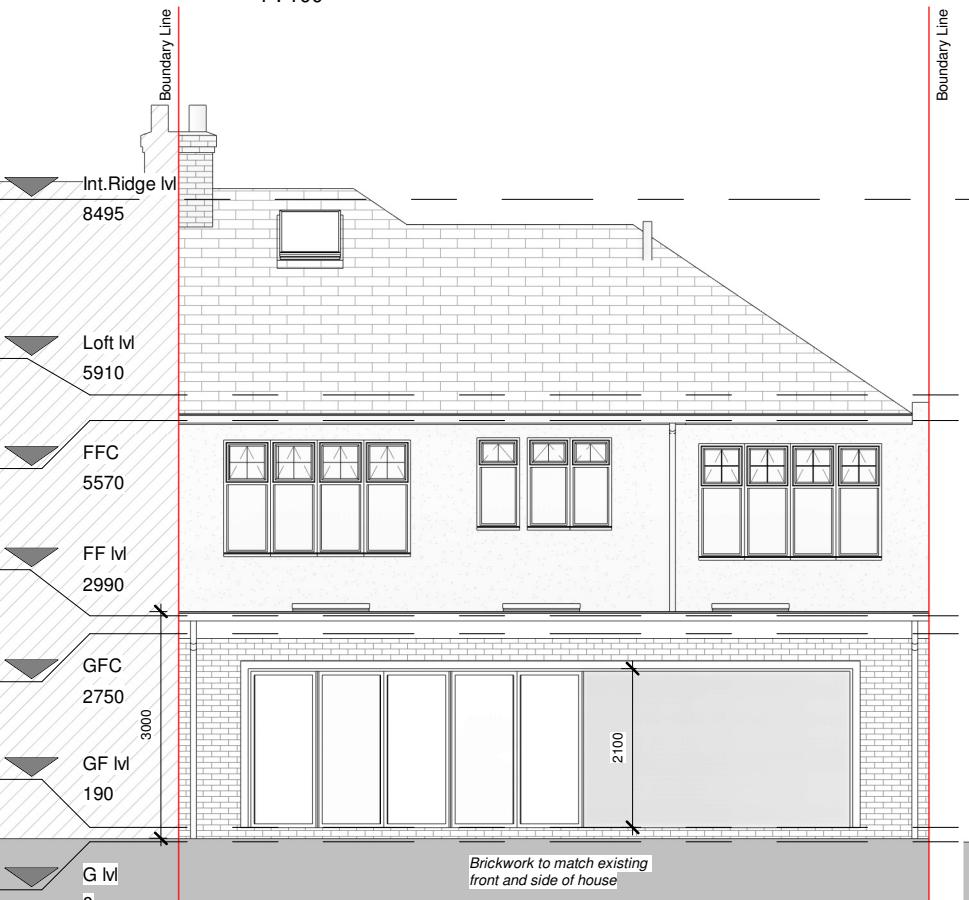
Left elevation

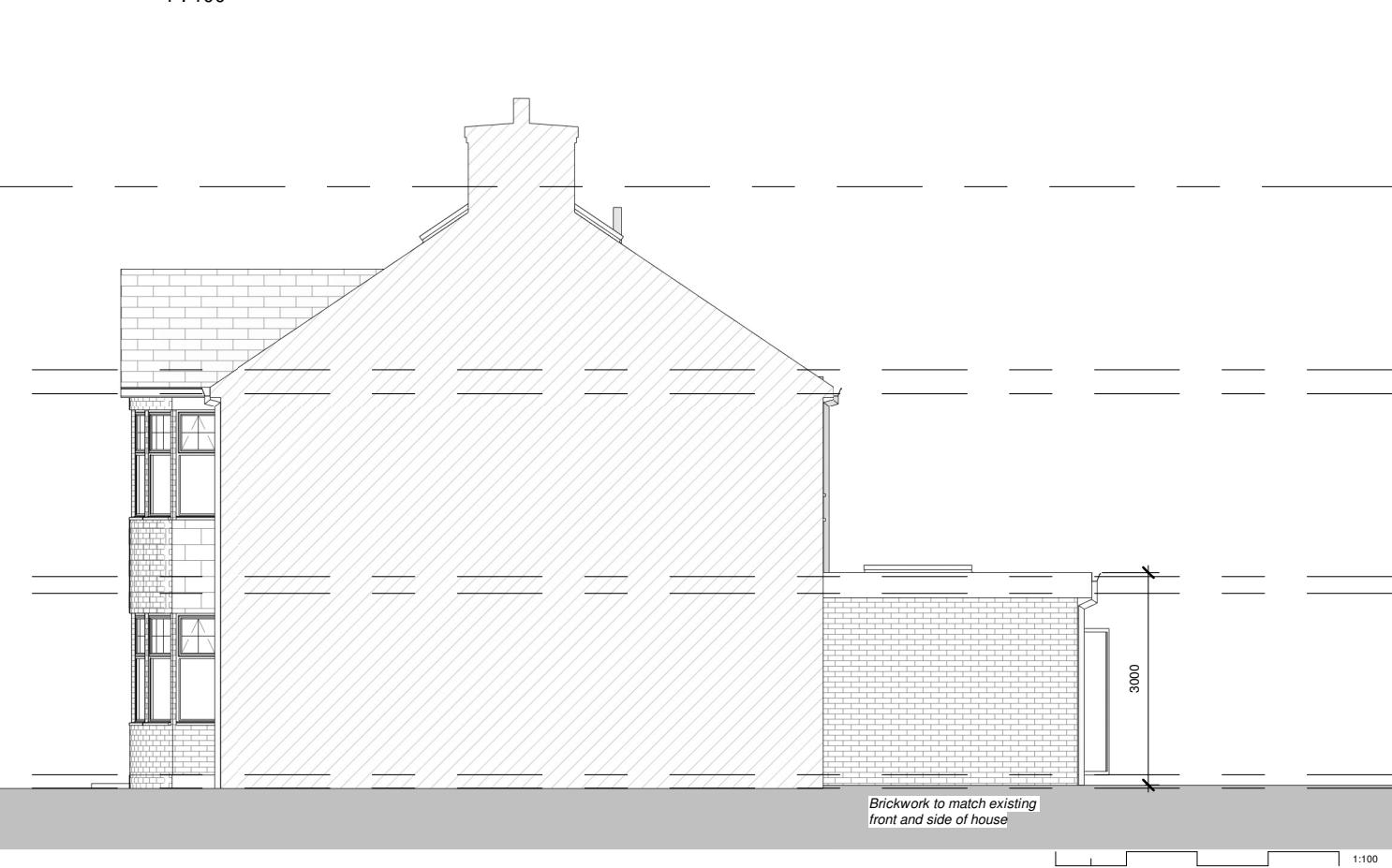
Rear elevation

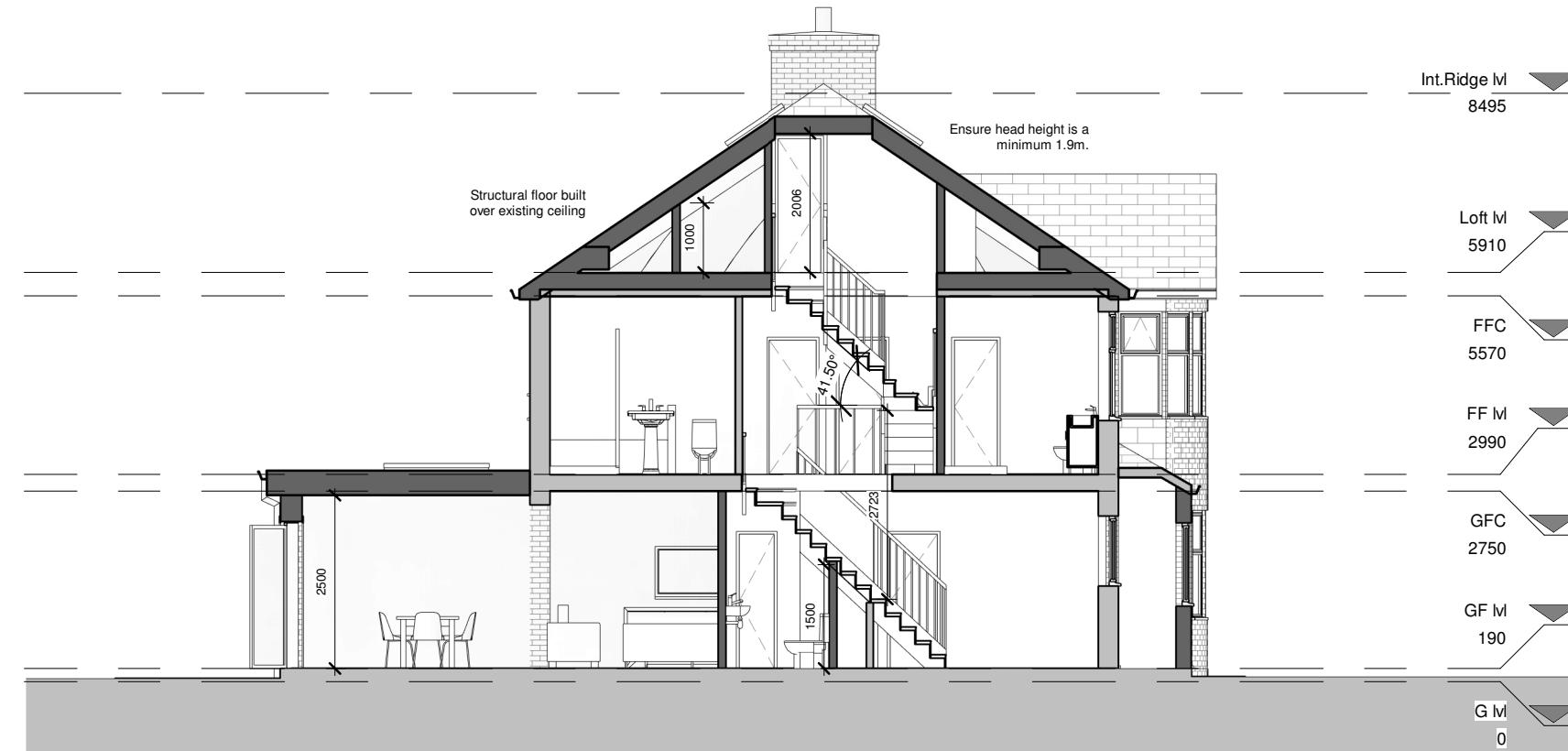
