Priority U (Urgent) works as per survey 32208 recommendations

Tree numbers - T22 Lilac (*Syringae* sp.) - Remove as close to trees current ground level as possible, leaving the stump in the ground.

G25 Elder (*Sambucus nigra*) - Remove as close to trees current ground level as possible, leaving the stump in the ground.

T37 Hawthorn (*Crataegus monogyna*) - Remove as close to trees current ground level as possible, leaving the stump in the ground.

T39 Goat Willow (*Salix caprea*) - Remove as close to trees current ground level as possible, leaving the stump in the ground.

T42 Ivy covered stem - Remove as close to trees current ground level as possible, leaving the stump in the ground.

Priority A works as per survey 32208 recommendations

Tree numbers - T6 Goat Willow (*Salix caprea*) - Remove as close to trees current ground level as possible, leaving the stump in the ground.

T10 Goat Willow (*Salix caprea*) - Remove as close to trees current ground level as possible, leaving the stump in the ground.

T14 Hawthorn (*Crataegus monogyna*) - Remove as close to trees current ground level as possible, leaving the stump in the ground.

T23 Alder (*Alnus glutinosa*) - Remove major deadwood over 40mm diameter and/or over 1m length. Reduce height by around 2.5m and spread by upto 1m, pruning to suitable growth points/branch fork junctions.

T24 Alder (*Alnus glutinosa*) - Remove major deadwood over 40mm diameter and/or over 1m length. Remove stub at 8m to encourage proper healing.

T32 Cherry (*Prunus avium*) - Fell dead stem nearest road. Reduce remaining crown by around 1.5m all round.

T49 Ash (*Fraxinus excelsior*) - Remove major deadwood over 40mm diameter and/or over 1m length.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
