### Conclusion

At present there are concerns regarding the proposed development on the neighbouring amenities of number 8 Beacon Close. It is recommended that within any formal application a sunlight/daylight assessment is submitted to assess the impact further. Drawings showing the 45 degree line of sight from all of the closest neighbouring habitable room windows should also be provided. As the site levels at the rear of the property are shown to be increased with a new patio area, additional information and drawings should be submitted within a formal application with potential mitigation measures to prevent overlooking/loss of privacy to both neighbouring properties.

It is recommended that the depth of the single storey rear extension is reduced to reduce its visual impact on the existing property and surrounding area. On balance, with minor amendments it is not considered that the development would cause substantial harm to the character and appearance of the surrounding area nor the original property given the existing developments at neighbouring properties numbers 12 and 14 Beacon Close.

Given the number of trees and soft landscaping at the site, within any formal application, a Tree Survey, Arboricultural Impact Assessment, Method Statement and Tree Protection Plan should be submitted to assess the impact further. This would be subject to consultation with the Councils tree/landscape officer.
